- 3) End of month balance for the gambling checking account was \$7,571.
- 4) Seeking to pre-approve \$5,000 for the month of September 2007 payable to SYRC. Motion to accept by Todd Minkel. Second by Doug Ferns. Motion carries.
- 5) Still researching Bar Bingo at the Blue Line & Riverboat Depot. Need to have 20 people to play game. Need a caller, banker & seller at \$7/hr. to run the games. Holding off until October to see if its feasible for us to take on this commitment.
