President - Dave Ruelle called the meeting to order at 7:00pm

Secretary - Victoria Wright- Minutes presented from the March 8, 2009 meeting. Motion called for rby Dave Ruelle to approve minutes. Motion by Dave Anderson. Second by Dan Thielen. Motion passed.

Treasurer - Connie Buesher - Budget presented. Almost all uniforms paid for. Everything is current.

- Other clubs using our fields. May need to address with city (ie: Bloomington club based decision on a percentage of players on the team represented)
- Need to contact MTA president.
- Call city for clarification
- Meg K-May proposed that 70% of any team must be a resident of the ISD 719 school district in order to use any fields issued to PLSC. Second Dave Anderson. Proposal passed.

Registration and Tryout process procedure presented by Stacey Ruelle. Looked at Lakeville Soccer Club as an example.

- U11-U17 Announce all at the same time
- If you accept and team will play fall- need to communicate fall registration. Exception will be if there isn't a team/coach.
- Need to communicate for U9/U10 transition from inhouse to fall.
- Need to have team and coach formed by June for fall.
- Open up registration for everyone June 1 for fall U9 and U14. Spring/Summer of following year.
- Impose late fee of \$75.
- Do a travel day/open house during Jamboree.
- Have a connection to PLHS soccer camp.
- U9/U10 December 31 registration deadline.
- U13 and up fees increase by @\$45 to cover more (ie: to hire coaches, administration cost increase.)
- Discuss C3 level teams coaching commitment and do we go to a parent coach and use increase in fees for in season training?

- Need to relook at tryouts. Separate select and/or travel. Need to finalize tryout schedule. Consider borderline kids. Skills. Coaches' input.
- Discussion about Jamboree on June 27 - Lauren Huntington, Kari Ornes U12, Gretchen Anderson, will organize.
- Schwan's Fundraiser June 20 at Ryan/Ponds. 20% goes back to the club presented by Kari Ornes.

- MYSA- Coerver Training - Tom Courchene - needs to confirm with club and city. Lots of club activities and camps. Could distract from our own club camps. Why not Burnsville? Procedure needs

to be followed.

- Discuss - need to provide information for all camps. Check website for information.

Risk Management - Bruce Zutter - nothing - needs to check fields. Any info of needs let Bruce know.

Equipment Manager- Dan Thielen- if you need anything let Dan know.
