

**Fond du Lac Soccer Association**  
**May Board Meeting**

5/16/2010

The Fond du Lac Soccer Association (FDLSA) February Board Meeting was held on Sunday, May 16<sup>th</sup>, 2010 at the FDL Soccer Complex. Members present include Benji Winter, Mark Daniels, Donovan Heavener, Dave Moehn, Greg Winkler, Lisa Blackstad, and Gina Rosado. Mark Daniels called the meeting to order at 7:00 pm.

- 1) Call to order.
- 2) East Central Update (Benji Winter)
  - a) Donation to UWGB Family
  - b) Coaches need to enter scores through East Central Website.
  - c) East Central Try-Out Regulations and Dates are out.
  - d) Referees need to check coach passes.
  - e) Possible "Blow-Out Rule" was discussed.
  - f) Upcoming East Central Meetings: Need an FDLSA Board member to attend June Mtg.
  - g) FDL Soccer Association opted into the July series for Select Teams. Only teams to opt out are U10 Boys (Kohlman) and U13 Boys (Kobilic).
- 3) Recreation Committee Update – (Mark Daniels)
  - a) Registration for adult league – Only had 5 people registered for the adult league, so league will not exist. Will try again next year.
  - b) High School (U15-U19 League) – Have 58 registrations (4 full rosters). The deadline was 5/15. Remind players to get registrations in.
  - c) Jerseys – Lots of wrong uniform sizes. Does the FDLSA need to change the registration form? Parents and players are happy with the new jerseys.
  - d) Field numbering is fixed for next year.
  - e) Walleye Weekend:
    - i) U10 and up are playing. Girls on Saturday and boys on Sunday.
    - ii) FDLSA will provide water for referees.
    - iii) Who can help?
    - iv) Can we set up remote TV so people can see the first day of the 2010 World Cup?
    - v) Schedules are done and will be out to coaches this week.
    - vi) Trophies and medals are in.
    - vii) Cost Cutters pays for refs, trophies and medals. (\$10 for U10 refs and \$15 for U12 & U14 refs.)
  - f) Mark Daniels will check on first aid kits for coaches.
- 4) Travel Coordinator Report – (Greg Winkler)
  - a) Try-outs are as follows:

    - ii) Wednesday, June 30, 2010 @ 5:30 pm to 7:00 pm for U14 Girls
    - iii) Wednesday, June 30, 2010 @ 7:00 pm to 8:30 pm for U14 Boys and U15 Girls
    - iv) Thursday, July 1, 2010 @ 5:30 pm to 7:00 pm for U10 Girls and U11 Girls
    - v) Monday, July 5, 2010 @ 5:30 pm to 7:00 pm for U10 Boys and U11 Boys
    - vi) Monday, July 5, 2010 @ 7:00 pm to 8:30 pm for U12 Boys and U12 Girls

- vii) Make-up try-out date for all ages – Monday, July 12, 2010 @ 5:30 pm
  - b) Motion by Greg Winkler to increase FDLA Select Soccer fees to \$200. Second by Donovan Heavener. Motion passes.
  - c) Motion by Greg Winkler to have 4 people present at try-outs to evaluate players given that none of the evaluators can be coaches of the age group being evaluated. These evaluators will be paid at a rate of \$25 per hour. Second by Donovan Heavener. Motion passes.
  - d) Motion by Greg Winkler to hire 7 trainers to work with FDLA Select Teams. One trainer per age groups as follows: U10 - U12 Girls, U10 - U12 Boys, U13 - U14 Girls, U13 - U14 Boys, U15 and up Boys, U15 and up Girls, and a trainer for Goalkeepers. Trainers would begin on 8/1/2010 and would provide 15 training sessions at 1/5 hours per session. Cost would be \$1000 per trainer. Second by Dave Moehn. Motion passes.
- 5) Grounds & Maintenance Report –(Benji Winter)
- a) Field signs will be up by May 17th.
  - b) Fields will be fertilized this week.
  - c) Closing fields: Have Athletic Directors from respective high schools present to check fields with FDLA (Fond du Lac High School and Wisconsin Lutheran Academy) in the event of possible cancellation of games due to field conditions. Grounds and Maintenance Coordinator will contact them.
  - d) Troy Kohlman knows someone who can advise the FDLA as to different options with drainage on Field #1. Contact him and follow-up with possible options.

  - g) End of Year FDLA Rec. Tournament schedule is done through U10s and U13s. Games will be 2-20 minute halves. Games will be played on the hour. (Benji Winter)
