### *Contest Execution Requirements and Client Responsibilities for eligible reimbursement of prize(s):*

1. A contestant will qualify for the prize award if they successfully pass, punt then successfully kick a field goal from the resulting designated spot on the field for each respective attempt beginning behind the back chalk line of the end zone line.
2. All eligible contestants must be randomly selected by a method that is approved by SNP:
3. Contestant(s) must sign an official finalist affidavit of eligibility immediately prior to their toss attempt.
4. The following classes of people are ineligible to compete in this contest:
  - Current or former professional, Olympic, semi-professional or minor league football, soccer or rugby players.
  - Current or former high school or collegiate football, soccer or rugby players who have competed at that level within the past six (6) years.
  - Current or former football, soccer or rugby coaches who have coached at the high school level or above within the past six (6) years.
5. The following restrictions apply to the administration of this event:
  - Pass – The contestant must pass a regulation NCAA, NFL or state high school association football of regulation size and weight from behind the out of bounds line (back chalk line) at one end zone that measures a minimum of 120 yards from the opposite field goal post.. The resulting spot on the field from their pass attempt will be designated as the spot in which the ball initially makes contact with the inbounds playing surface. The ball may not bounce or roll to a further distance on the field. In the event that the ball lands out of bounds, the spot on the field will be designated as the point in which the ball first crossed the out of bounds line as designated by the referee or contest official.
  - Punt – The contestant must then punt the football from the designated spot on the field resulting from their own pass attempt. The resulting spot on the field will be designated as the spot in which the ball initially makes contact with the inbounds playing surface. The ball may not bounce or roll to a further distance on the field. In the event that the ball lands out of bounds, the spot on the field will be designated as the point in which the ball first crossed the out of bounds line as designated by the referee or contest official.
  - Kick – The contestant must then kick a successful field goal attempt from the designated spot on the field resulting from their punt attempt. The ball is placed at the exact spot where the punt attempt initially made contact with the inbounds playing surface, the ball is not to be centered or placed on a hash if the ball did not land there. The football must cross over the crossbar and go between the uprights of the regulation High School, NCAA or NFL goal post at the opposite end of the field from which their contest attempt initiated.
  - The pass, punt and field goal kick attempt must all be made in a forward motion down the playing field toward the opposite goal post from which the contestant begins his or her attempt.
  - A foot fault (plant foot touching or crossing the kicking or passing line) on any punt, pass or kick attempt will disqualify the attempt. A contestant will not be allowed another attempt and the contest is over.
  - During the field goal attempt the football must be held by an individual or a simulated holder (which is approved by SNP). No tee of any sort may be used in this promotion.
