**PLAYOFFS:**

- All teams have at least one playoff match after pool play.
- Top 2 teams from each pool advance to the Championship bracket.
- The two 3rd place teams with the best record advance to the Championship bracket.
- 4th place teams work the first round of playoffs, then the loser stays to work next match.

**Playing Format:**

- 1) All matches will be best 2 of 3 sets to 25 points with a 15 point deciding set, if needed.
- 2) Warm-ups will be 2-4-4 for each teams first match, and then 3-3 the rest of the day.
- 3) Tie breaking procedure (note, no sets will be played for any ties):
  - If 2 teams are tied (in order):
    - + Match won/loss in head to head play
    - + Sets won/loss in head to head play
    - + Points won/loss in head to head play
    - + Point won/loss percentage (won/(won+lost)) in the entire pool
    - + Coin toss
  - If 3 (or more) teams are tied (in order):
    - + Set percentage in the entire pool
    - + Point won/loss percentage (won/(won+lost)) in the entire pool
    - + Coin toss
- 4) Each work team must supply the following:
  - Down Ref (R2)
  - Libero Tracker
  - Scorekeeper
  - Flipper for score cards
  - 2 lines people per game
