## LIABILITY WAIVER, RELEASE OF ALL CLAIMS, AND HOLD HARMLESS AGREEMENT

For Anthony Ford Pond Hockey Tournament  
At Spring Lake Park in North Mankato, MN

### READ CAREFULLY

Read this form carefully. By registering for and participating in the Anthony Ford Pond Hockey Tournament ("Tournament") you will be waiving and releasing any and all claims for injuries that you and/or the above participant might sustain arising out of the Tournament. The terms "I," "me," and "my" also refer to parents, custodians, guardians, or conservators of participants, as well as the participants in the tournament, including any and all of their heirs, personal representatives, administrators and assigns.

In registering for and participating in the Tournament, I agree as follows:

As a participant in the Tournament, including as a Natural Parent, Custodial Parent, Guardian or Conservator of a minor child or of any other Participant in the Tournament, I recognize and acknowledge that there are certain risks of physical injury, including but not limited to those associated with natural conditions associated with a lake, weather and conditions of outdoor ice, and I agree to assume the full risk of any injuries, including death, damages or loss which I may sustain as a result of participating, in any manner, in any and all activities connected with or associated with the Tournament. I further recognize and acknowledge that all athletic activities involving strenuous exertion or potential body contact are hazardous recreational activities and involve substantial risks of injury, and as such understand the risks associated with my participation in the Tournament.

I waive and relinquish any and all claims that I, or my heirs, personal representatives, administrators and assigns may have as a result of participating in the Tournament against the Anthony Ford Fund and Mankato Area Hockey Association, and any and all other participating or cooperating sponsors or contributors, independent contractors, officers, agents, volunteers, servants and employees of the Anthony Ford Fund and Mankato Area Hockey Association, and any and all other persons and entities, of whatever nature, that might be directly or indirectly liable for any injuries that I might sustain while participating in the Tournament (all parties described in this paragraph hereinafter referred to as the "Released Parties").

I hereby, for myself and my heirs, personal representatives, administrators and assigns, fully release and discharge the Anthony Ford Fund and Mankato Area Hockey Association and all other Released Parties from any and all liability and claims for any negligence, implied or otherwise, for personal injuries, including death, property loss, or damage or loss of any kind which I may have or which may accrue to me on account of my participation in the Tournament.

I hereby, for myself and my heirs, personal representatives, administrators and assigns, assume all risk whatsoever, for personal injuries, including death, property loss, or damage or loss of any kind which I may have or which may accrue to me on account of my participation in the Tournament.

I hereby covenant and agree, for myself and my heirs, personal representatives, administrators and assigns, not to sue, attach or prosecute the Anthony Ford Fund and Mankato Area Hockey Association and all other Released Parties for any and all liability and claims for any negligence, implied or otherwise, for personal injuries, including death, property loss, or damage or loss of any kind which I may have or which may accrue to me on account of my participation in the Tournament, it being my express intent and purpose to bind myself, and my heirs, personal representatives, administrators and assigns.

I agree to indemnify, hold harmless and defend the Anthony Ford Fund and Mankato Area Hockey Association, and any and all other Released Parties, from any and all claims resulting from injuries, including death, damages and losses sustained by anyone, and arising out of, connected with, or in any way associated with my conduct and the activities of the Tournament.

I understand and agree that terms such as "participation," "Tournament," and "activities," referred to in this Agreement, include all exercises and physical movements of any nature while I am participating in the Tournament, and further include the provision of or failure to provide proper instructions or supervision, the use and adjustment of any and all equipment, machinery and apparatus, and anything related to my use of the services, facilities, or premises involved in the Tournament.

I understand the nature of the Tournament for which I am registering, and have read and fully understand this Waiver, Release and Hold Harmless Agreement. I further understand that any advisements or warnings of the particular risks of this Tournament that I subsequently receive will be incorporated by reference into and become a part of this Agreement.
