If approved the District Director of the league in which the team desires to participate must approve the team for league play.
2. The geographical area of jurisdiction as defined in 1.1.1 of this agreement shall be city of St. Paul, north of Highway 94, an area that is jointly shared with the Johnson/Como Hockey Association (Johnson/Como) an association being duly affiliated with Minnesota Hockey.
3. If a player who resides in the geographical area defined above desires to participate with an association other than Langford Park, that player must either participate with Johnson/Como or seek a waiver from Johnson/Como in accordance with the Youth Rules and Regulations Participation Rule IV.B.1., as defined in the Minnesota Hockey Handbook. Nothing in this agreement shall be constructed as according Langford Park the authority to waive players on its playing rosters.

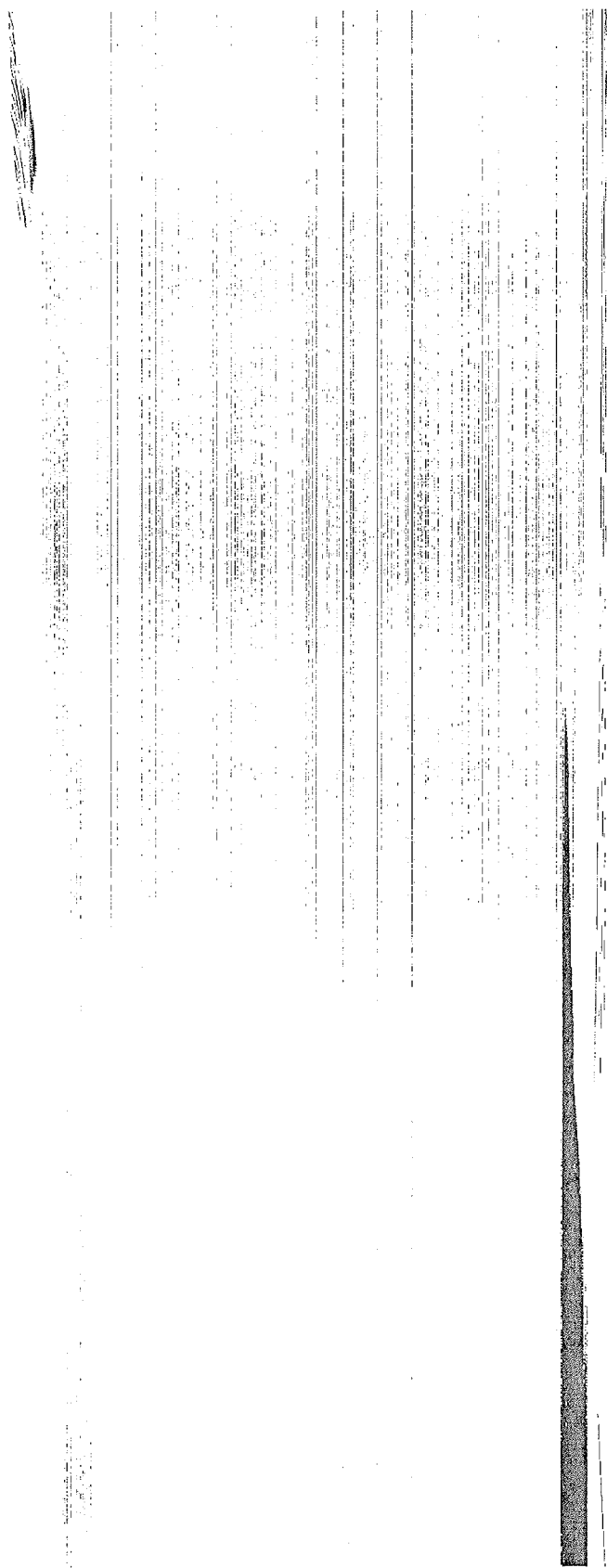
