I understand that if anything at the Glacier Canyon Conference Center at the Wilderness Resort, Wisconsin Dells, WI, is broken and/or stolen by our coaches or athletes, our school or organization will be responsible for replacing and/or repairing it, whichever is deemed appropriate by Glacier Canyon Conference Center at the Wilderness Resort Wisconsin Dells, WI.

I will not hold WACPC or Glacier Canyon Conference Center at the Wilderness Resort, Wisconsin Dells, WI, responsible for any valuables that would be missing at any time.

I understand that it is my responsibility to have on my person any and all emergency information for all of my athletes. To my best knowledge none of my athletes have conditions which would prohibit or restrict her/his participation. I have obtained permission from my athlete's parents/guardians to allow their child to participate in the WACPC Fall Conference at the Glacier Canyon Conference Center at the Wilderness Resort, Wisconsin Dells, WI.

I acknowledge any stunts performed by our athletes will follow NFHS safety rules and will have team spotters as necessary for the safety of my athletes. I understand that my athletes will not attempt anything that is beyond their ability and that I as a coach understand the ability level of all my athletes and will not hold WACPC responsible for any injuries incurred in doing anything beyond their abilities.

I have informed my athletes, parent/guardians of the inherent and significant risk involved with the sports of cheer and dance. The risks of injury involved in cheer and dance are significant and while participation rules, equipment, and personal discipline, may reduce this risk, the risk of serious injury does exist. All parent/guardians have KNOWINGLY AND FREELY ASSUMED ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for their child's participation. All such forms will also RELEASE AND HOLD HARMLESS WACPC, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable owners and leasers or premises used to conduct event, WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss, damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE REALEASEES OR OTHERWISE. During the athletes stay at the event site, all athletes will be closely supervised in every activity. It is to be understood that the Wisconsin Association of Cheer and Pom Coaches, Inc. (WACPC) and Glacier Canyon Conference Center at the Wilderness Resort, Wisconsin Dells, WI cannot be held responsible for any act of God or unforeseen incident that might occur on the way to and from the event. WACPC and Glacier Canyon Conference Center at the Wilderness Resort, Wisconsin Dells, WI will not be liable or responsible for any injury, loss, damage, or delay resulting from any act of neglect of any person or company whose services are retained by WACPC for the benefit of program participants. Furthermore, WACPC and Glacier Canyon Conference Center at the Wilderness Resort, Wisconsin Dells, WI cannot be held responsible for any act, error, or omission on the part of any program participant or participants. Additional expenses if incurred under any of these circumstances must be borne by the program participants. It is understood that WACPC has a NO REFUND policy. It is understood that WACPC and Glacier Canyon Conference Center at the Wilderness Resort, Wisconsin Dells, WI cannot be held responsible for any discipline problem encountered with an athlete. Any athlete possessing or using drugs or alcohol or behaving in any manner inconsistent with WACPC standards or local, state, or federal statutes will be immediately dismissed from the program. The parents/guardians and organization will be notified. WACPC and Glacier Canyon Conference Center at the Wilderness Resort, Wisconsin Dells, WI will not be held responsible for loss or damage to an athlete's personal belongings.
