



CHIEFS D230 HIGH SCHOOL LACROSSE

Welcome to the D230 Chiefs 2015 Lacrosse season! This season, my wife Elena and I will be taking orders for the official Chiefs helmet wraps and decals. For those that don't know, a helmet wrap is a decal with the official "feathers" logo that wraps around the helmet. This is necessary for those who have purchased helmets that are not the official Chiefs uniform color, yellow. The wrap is yellow with the feathers integrated into the design, so wrapping, say a blue helmet, will make the helmet compliant with the Chiefs team helmet. The wraps are custom made to fit the cascade R, CPX-R, and Pro 7 helmet models. If you have, or plan on ordering your player a yellow helmet, you can order the feather decal alone, at a cheaper price. It is strongly suggested that you order a yellow helmet if you haven't already. The feather decal can be ordered for the above mentioned Cascade helmets as well as the Cascade CPX, CLH-2 and CPV helmets. You may also order the feathers only decal for the Warrior T2 and Regulator models. Prices are \$32 for the full wrap, and \$17 for the feather decal. To receive the wraps and decals in time for the 2015 season, we need to have the order placed by the end of December.

To clarify, full wraps can be ordered for:

Cascade: R, CPX-R, Pro 7

Feathers only decals can be ordered for:

Cascade: R, CPX-R, Pro 7, CPX, CLH2, CPV

Warrior: T2 and Regulator are feathers only decal.
