Attachment to Amendment to Articles of Incorporation for STMA Girls Basketball Club

Article II of the corporation's Articles of Incorporation shall be amended by deleting the existing text and replacing it, in its entirety, as follows:

II.

This corporation is organized exclusively for charitable purposes as specified in Section 501(c)(3) of the Internal Revenue Code, as amended, more specifically, for such purposes as (i) promoting and supporting amateur athletes ages 18 and younger in the sport of basketball within the St. Michael/Albertville School District ("District"); (ii) planning and facilitating a safe activity for youth in the District from different backgrounds, both ethnically and financially, (iii) educating the athletes, coaches and fans in the District about the sport of basketball; and (iv) for making distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, as amended. The purposes and powers of this corporation are limited to the purposes and powers consistent and in conformity with Section 501(c)(3) of the Internal Revenue Code, as amended.
