1. Welcome, devotions -Mary Claire

- 2. Approve minutes. M/S/P to approve minutes from January 19, 2017 meeting with one amendment of a name spelling.
- 3. Lead pastor reports/updates:
 - a. Installation This is scheduled for March 5, 2017 at 2:00 PM and the details are being organized.
 - b. Fundraising Pastor Chris discussed the recent document she received related to a request to do fundraising for a TLC member. This is not associated with a TLC mission; therefore, it is not a sanctioned event. Pastor Chris will communicate with this individual related to the Council's decision.
 - c. Vacation Bible School (VBS) update TCL is withdrawing from the relationship with Our Saviors for VBS for this year. There are some broad concerns related to the topic selection and structure of the program. This has been communicated with Our Saviors. TLC will do our own VBS in June.
 - d. The summer worship schedule will be 9:00 AM at the church and 10:00 AM at the drive in. One pastor will preach at both services. The bridge is scheduled to open in August 2017.
 - e. Sabbatical policy Pastor Chris has done some research related to sabbatical and the standard for other churches in the area. The Council requested a copy of the proposal and will be discussed further at the next meeting.
 - f. Pastor Chris discussed the large church conference, which would be about \$1,000. After research and discussion with other church leaders, there is a significant value to attending this conference. The Council approved this expense.
 - g. Worship of Love or Mission of the Month Pastor Chris discussed that she would like to initiate a monthly giving opportunity, such a food, school supplies, etc. This keep TLC's commitments present and visible. The would need to be reviewed by the Mission Board to create a proposal prior to approval by the Council. This models stewardship and educational component of the different programs.
 - h. Community Partnership with other churches The pastoral staff is meeting with other pastors in the community to find ways to build relationships. These conversations will continue about how to elevate the collective work of the church community.

- 4. Synod Assembly voting member approval Gail, Mary Claire, Arba-Della, Doug and Michelle Hermansen will be attending the assembly. The Council approved these attendees, but we do have 4 more slots.

 - c. Budget updates were provided The budget and information was reviewed by the Council.
