Player Contract Continued:

Mission Statement: Here at THR33 VBA, we want to provide our athletes with quality training in the most competitive atmosphere possible. Through this training, we will develop our athletes into players that can succeed at the next level.

Practice Schedule: All THR33 VBA teams require dedication on the part of the athlete for the team to be a success. The girl's club will begin practice in November and continue through May depending if your team will participate in nationals. Practice venues will be at the THR33 home facility (Missouri Advantage Sports Training) and the Nixa School District.

Practice Rules:

- 1) If an athlete cannot be at practice, the athlete is expected to call the coach with an explanation. It is the athlete's responsibility (not the parent's) to reach the coach before the practice starts. Reaching a coach means just that – you must make sure that you make contact with a coach and they reply to a call, email, or a text. Do not leave a message and expect that the coach will receive it.
- 2) Scheduled practice time is start time; not arrival time. Plan on arriving at least 15 minutes prior to the start of each practice.

Playing Time: We do not guarantee equal playing time on any team or at any event.

2) Playing time for athletes is determined by attendance, attitude, effort, performance, the athlete's potential, the team's needs at the moment, the team's needs in the future, and is left solely to the discretion of the THR33 Coach.

4) The "coaching decision" is not up for debate or question. It is the athlete's responsibility to ask what they can improve on to get more playing time. Athletes will be expected to play in any position to benefit team performance.

5) While representing THR33 VBA, all athletes are expected to behave in a responsible manner. THR33 VBA intends to promote nothing but the highest of standards and a professional image. Those that have previously gone through this program have worked hard at establishing THR33 VBA Volleyball as a class operation. Adherence to the player/parent handbook is required.

Payment:

1) Deposit will be due on the day of signing (July 21st), the first payment will be due October 10th, all remaining balances are to be paid by the 10th of each month thereafter. Club fees can be paid in full, or split up in 2, 4, or 6 payments. Total balance must be paid by the end of February.

2) By signing the contract you agree to pay the full amount as agreed upon per your team. You are required to pay the full amount whether you complete the season or not (with the exception of medical leave).
