

Mitchell Activities Center Rules:

The following rules are intended for the safety and consideration of all patrons:

- Mitchell Activities Center is a City owned facility- City Employees have final authority
- Maintain reasonable control of your direction and speed at all times.
- Read and abide by all posted signs and warnings and abide by instructions from all rink staff.
- Skates must be worn on the ice during public skating, no street shoes.
- Only skate aids are permitted on the ice during open skate or ice rental time.
- Skaters are not permitted to carry other skaters or small children on the ice.
- Will not skate in chains of more than 2 skaters.
- Will not play tag or any such games on the ice.
- Will abide by all instructions from City of Mitchell Employees.
- Maintain a proper lookout to avoid other skaters, objects, or conditions on the ice surface.
- Accept responsibility for knowing range of your ability while on skates and skate within the limits of that ability and as appropriate to the session on which you are skating.
- Refrain from skating while under the influence of alcohol, drugs, or other control impairing substance.
- Leave the ice surface when the resurfacing maintenance (Zamboni machine) is taking place. Do not re-enter the rink until permitted by staff.
- NO food or drink is allowed on the rink surface or the surrounding dasher or cap rail, team benches or scorer's area.
- Horseplay of any kind will not be tolerated
- No pets allowed in the facility
- Dry-land activities may not include sticks, pucks or balls of any type, except in the City designated shooting cage located in the north rink.
- Place all garbage in receptacles throughout the arena
- Refrain from acting in a manner that may cause or contribute injury to you, other skaters or spectators.
- Refrain from throwing or leaving objects on the rink surface.
- Refrain from instigating or becoming involved in any type of altercations with any other skater or spectator.
- NO abusive acts or language is permitted in the facility.
- **Assumption of Risk:** By engaging in skating, skaters and spectators are deemed to have knowledge of, and assume the inherent risks of skating, which include, but are not limited to the following:
 - a. Injuries that result from collisions with other skaters or skate guards.
 - b. Injuries that result from falls.
 - c. Injuries that involve objects or artificial structures that are within the intended path of travel of the skater

Other Facility Rules include: NO running, climbing on tables and benches, swinging or throwing objects in the facility. Children under eight years old will not be left unattended in any area of the facility.

Outside food and drink is not permitted in the building when Concessions are open or without direct permission from Management.

Any injuries or abuse of rules should be reported to an arena worker immediately.

Any patron who fails to follow these rules may be asked to leave the facility.

Patrons will not be given a refund if asked to leave the facility.

The Mitchell Activities Center is a Zero Tolerance Facility
