In consideration of being permitted to participate in the activities of Detroit City Futbol, I, on behalf of myself and my heirs, represent, warrant, and agree to the following: I do not have any health-related conditions, disabilities, etc., that would restrict my participation in Detroit City Futbol activities. I understand the risks of participating in Detroit City Futbol activities and that participation in Detroit City Futbol activities can result in bodily injuries or even death. I hereby accept and assume the risk of and full responsibility for any loss, property damage, personal injury or death, which may be sustained as a result of my participation and involvement in Detroit City Futbol activities. I have read and understand the Rules and Regulations provided by Detroit City Futbol and agree to abide by them. I agree to hold harmless and indemnify Detroit City Futbol, its organizers, captains, volunteers, sponsors, and all participants (hereafter collectively referred to as "Detroit City Futbol") from any and all claims, actions, losses, costs, expenses, damages, and liabilities, including actual attorney's fees and related costs, that may be incurred as a result of my participation in Detroit City Futbol activities. It is my intent that Detroit City Futbol shall not be liable for any damage, loss or injury to me in any way connected to my participation in Detroit City Futbol activities and I hereby release and discharge Detroit City Futbol from any liability for damage, loss or injury to me in any way connected to my participation in Detroit City Futbol activities. I acknowledge and agree that my relationship and involvement with Detroit City Futbol does not create a bailment and that Detroit City Futbol is not responsible for any items that are lost, stolen, or damaged. I AGREE TO WAIVE THE RIGHT TO A TRIAL BY JURY OF ANY MATTERS ARISING OUT OF OR IN ANY WAY CONNECTED TO MY PARTICIPATION IN DETROIT CITY FUTBOL ACTIVITIES. I agree that Detroit City Futbol League has complete ownership of such pictures, etc., including the entire copyright, and may use them for any purpose consistent with the Detroit City Futbol League missions. These uses include, but are not limited to illustrations, bulletins, exhibitions, videotapes, reprints, reproductions, publications, advertisements, and any promotional or educational materials in any medium now known or later developed, including the Internet.
