I (we), the undersigned parent(s)/legal guardian(s) of the above player, by executing this Tuition Contract, agree and understand as follows:

1. I (we) are financially responsible for the full season *Financial Obligation* as detailed below.
2. If the payers named above fails to complete the season for any reason, I (we) will not be entitled to any refund or reduction in program fees or expenses. Failure to complete payment shall result in removal of player from team roster.
3. Above player must submit a signed MEAHA release form, from their previous organization. (SMYHA players exempted)
4. Any outstanding tuition balance or other fees due to SMYHA from prior years must be paid in full before this Contract will be accepted by the SMYHA – Breakers Division.

	Payment Plan (Online): Begins April 15, 2020. After online Registration payment, the Remaining Financial Obligation will be divided into equal monthly auto payments charged to your credit or debit card, the last payment as stated by division below. Registration opens April 2, 2020 (new season USA Hockey number is required)
	Payment in Full (Online): The Remaining Financial Obligation must be paid in full at time of online registration. Registration must be completed prior to May 15 th . (Registration must occur within 30 day of online registration being open.)

6. The *Financial Obligation* will be paid as follows on a payment plan: **Deposit of \$225 is paid at the time of Contract Signing**
 - a. **For Co-ed Squirts, Peewee, Bantams - (Valley League)** – Tuition \$1950: \$345.00 (\$150 for goalies) is due at April Registration and \$345.00 (\$150 for goalies) is due on May 15th, June 15th, July 15th, and August 15th, 2020, via the online payment plan.
 - b. **For Midget U16 or U18 (MEAHA League)** -Tuition \$1000: \$200 (\$150 for goalies) is due at April Registration, and \$192 (\$125 for goalies for May only) is due on May 15th, June 15th, and July 15th, 2020, via the online payment plan.
 - c. **For 19U Girls** – (NEGHL & MEAHA) Tuition \$750: \$150 (\$150 for goalies) is due at April Registration and \$125 (\$0 for goalies) due on May 15th, June 15th, and July 15th, 2020, via the online payment plan.
