Work Play Contract

This contract is entered into by and between San Diego & Seaside Volleyball Club (hereinafter referred to as "The Club") and _____ (hereinafter referred to as "Family") parent(s) of _____ (hereinafter referred to a "Player") on the date of execution of this contract under the terms and conditions outlined below:

Commencement of Work Play Agreement

Effective from _____ through _____. The Club and the Family will connect (via email, phone call, or in person) within 7 days before or after the end of the agreement to renew the contract depending on both the needs of The Club and of the Family.

Overall Expectations

Families and Players are expected to only sign up for and step into the roles that are outlined within this contract. If they sign up for a role outside of their contract, it will be canceled.

Families and Players are required to schedule their shifts using the online SignUp form. They are also required to track their hours via a tracking form provided by the Club.

Families and Players are expected to arrive on time and ready to go at the start time of each shift. Showing up late to a shift once (for a reason other than a true emergency), will result in a warning. Showing up late to a shift twice (for reasons other than a true emergency), will result in a one month suspension for that particular person from the Work Play Program.

Families and Players are required to provide at least 72 hours (3 days) notice in the event that they are unable to make the shift by canceling it via the online SignUp form. Cancelling a shift with less than 3 days notice once or not showing up at all (for a reason other than sickness or a true emergency), will result in a warning. Cancelling a shift with less than 3 days notice or not showing up at all a second time (for a reason other than sickness or a true emergency), will result in that person being dropped from the Work Play Program for the remainder of their contract.
