# Declaration Deadlines

October 15 - A state/affiliate and/or district shall signify their intention of entering a team or teams in the Girls Tier I, Youth Tier I, and Youth Tier II National Championship Tournament, in writing, to USA Hockey with a copy to the appropriate Youth or Girls Council chairperson by October 15 of the current season chairperson

November 1 – Varsity Teams must declare NTB.

November 15 - A district shall signify their intention of entering a team or teams in the Girls Tier II National Championship Tournament, in writing, to USA Hockey with a copy to the appropriate Youth or Girls Council chairperson.

November 15 - Affiliates shall signify their intention of entering a team(s) in any High School division national championships.

# RMD Tournament Fees

Team Entry Fees for Rocky Mountain District Championship Tournament are determined at Winter Meeting January 2026

Team Entry Fees for the 2025-2026 Nationals for all divisions: not to exceed \$2,000\*\*

Team Managers will receive fees and payment information from District Registrar once State/District Tournament winners are declared.

\*\*The 2026 team national tournament entry fee is \$2,000 per team. The 2027 and 2028 team national tournament entry fees are \$2,200 per team.

***NOTE: The Youth Tier I 14U and Youth Tier I 13O team national Tournament entry fee for 2026 is \$2,400 and for 2027 and 2028 is \$2,500.***

# Mandatory Coaches/Manager Meeting

- Meeting is typically held the evening before the tournament begins.
- All participating teams are required to have the head coach attend. It is recommended that the team manager also attend.
- No one person may represent more than one team at this meeting unless prior approval is granted by the Tournament Director.
- At the discretion of the National Tournament chair, failure to have the head coach present at the Opening Meeting shall result in the suspension of the head coach.
- Head coaches must check in with the National Tournament Director one (1) hour prior to their team's first game at the rink in which the game is being played..

# Game Requirements

## Girls Tier II

- 14/10 - Team is required to play 14 games and each player must play in 10.
- Max 20 players on a roster (18 skaters and 2 goalies).

## Youth Tier I and Tier II

- 20/10. Team must play 20 games, and each player must play in 10.
- Max 20 players on a roster (18 skaters and 2 goalies)

\*\*Legal names must be used on all game sheets.

\*\*It is recommended that teams come to District / Nationals with two (2) goalies.

# Game Requirements Cont.

## High School

- 10/5. Team must play in 10 games and each player must play in 5.
- 30 players for High School but can only dress 20.
- HS teams need to provide their Team Eligibility Declaration form

\*\*Legal names must be used on all game sheets.

\*\*It is recommended that teams come to District / Nationals with two (2) goalies.

# District Tournament

- Teams who win District tournament advance to the National tournament.
- National registration link will be sent to the head coach and team manager.
- Link will allow you to register your team, secure hotel rooms and pay the fee for Nationals.
- Register your team as quickly as possible
- National patches will be sent to you by the tournament host.

# Team Binder Overview

## Tips:

- NOW TO THE FUN STUFF!
- Don't panic! This looks like a lot of information, but it's broken up into easy-to-digest sections
- We are here to help and answer your questions.

- As Team Manager you are in charge of assembling your team's binder. This guide will tell you in what order your binder should be organized.
- Credentials will be sent electronically in one complete file to your Associate Registrar 3 weeks prior to State/District tournaments
- You will still need your physical binders on your person at both District and National tournaments for verification purposes.

# Team Binders

- Neatly organized in a three-ring binder
- Cover page including team name, level and manager contact information inserted on front of binder.
- Each document in plastic sleeves when you arrive at the district and/or national tournament.
- A divider tab with a title of the section displayed shall identify each section of the notebook.  
\*\*These divider pages are not required but appreciated in the electronic form.
- The required information shall be presented in the following order:

# CVS

## Credential Verification Sheet

### Tab 1

#### Credential Verification Form (CVS)

- All teams participating in Districts and Nationals are required to provide their teams credential verification sheet printed out from the USA hockey portal. Your affiliate registrar will provide each team this form which will populate all pertinent team information.
- CVS is to be completed for all Tier I, Tier II, and High School teams participating in District and/or National tournament. The credential verification sheet must include the game dates and show designation that each rostered player has met their 20/10, 14/10 or 10/5 game count.
- Cross off any players, coaches, LRM who will not be proceeding to District or Nationals.



# Official 1T Roster

## Tab 2

### Team Information (1T Roster)

- Certified (1T) Team Roster, with approval date no later than December 31.
- Cross off any players, coaches, LRM who will not be proceeding to District or Nationals.
- Ensure all players' DOB and Citizenship is verified.
- Ensure all players' jersey #s (home and away, even if they're the same!) appear on the roster.
- Ensure all players' positions are indicated on the roster (forward, defense, goalie).
- No players added after UAHA roster deadlines
- All LRM must be listed on Roster – no separate list will be allowed this year.

- Any games using paper score sheets require a referee(s) name and signature, or the game will not be included in the game count.
- If your copy of paper scoresheet is not legible, ask to take a picture of the first page.

# Game Sheets

- Game sheets *must* be legible.
  - Registrars will not break out the readers or play the “enhance” game!
- Electronic Game sheets *must* have coaches’ and referees’ names visible.
- Handwritten Game sheets *must* have coaches’ and referees’ signatures visible.
  - Game sheet must be presented in the order they appear on the CVS (see suggestions in later pages).
  - Take a picture on your phone of the legible first page of a 4-part scoresheet.

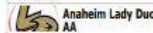

# Rules To Remember

- If your team has practice ice prior to District or Nationals, please remember if coaches are found non-compliant it will result in a Discipline Committee hearing with a minimum 30-day suspension from all activities involving USA Hockey registered programs.
- Ineligible Coaches/Players - Any coach that knowingly plays an ineligible player shall be suspended from coaching in any games that lead to a state/affiliate and/or district and national championship in the current season.
- Only (4) coaches allowed on the bench.
- As all levels of Districts/Nationals are in different locations at the same time, Coaches should not be dual rostered, if at all possible.

- High School – December 15
  - Tier 1 – February 6
  - Girls – February 6
  - Tier 2 – January 9

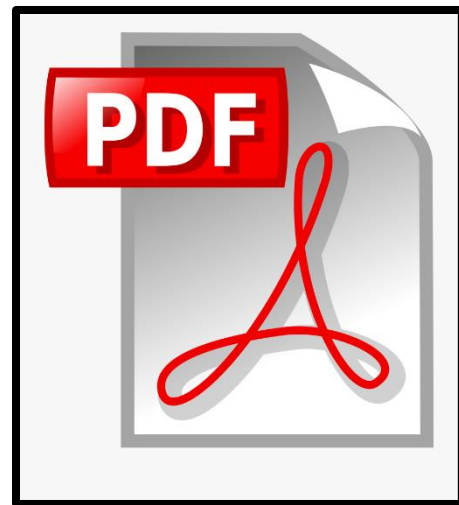
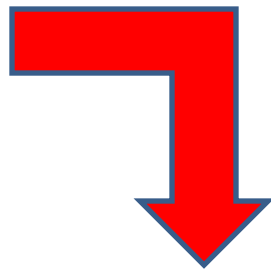

## Important Reminders

High School – March 26-30, 2025 – Irvine California

Team credentials must be submitted by the appropriate District Registrar to the designated Tournament Registrar for each National Tournament no later than seven (7) days after the conclusion of the District Tournament. If a team does not have a District Tournament, the team credentials must be submitted by the appropriate District Registrar to the designated Tournament Registrar for each National Tournament no later than March 1. Team credentials for at-large or teams participating in the last weekend of district tournaments must be submitted to the designated Tournament Registrar for each National Tournament no later than 24 hours after the completion of the District Tournament or notification of selection as an at-large team.

The team's certified player roster and credentials must be in the hands of the championship director one week before the start of the championship. Per the National tournament guidebook, I will need to have credentials to the championship director by March 19, 2025. To ensure I have time to review, I would like high school credentials in my hand no later than March 12, 2025.

For High School classification only, a verification signed by the Head Coach confirming that: I have attached the new verification form which I would suggest coaches not sign this form until end of semester to ensure players have not graduated mid-term.

# Important Reminders

High School – March 26-30, 2025 – Irvine California

A list of approved locker room monitors. (Note I would like to see all teams LRM listed on the 1T roster as this will show they have Safe Sport and background screenings. No list!

For High School classification only, a verification signed by the Head Coach confirming that:

- \* All players are enrolled, as full-time students or participate in a high school educational program;
- \* Are able to play varsity sports for the team; and
- \* That no player has already graduated from High School.
- \* Form will be sent out during credentialing process.

## Important Reminders

### Tier I Youth and Girls Credential Date

Team credentials must be submitted by the appropriate District Registrar to the designated Tournament Registrar for each National Tournament no later than seven (7) days after the conclusion of the District Tournament which will be March 16, 2025. If a team does not have a District Tournament, the team credentials must be submitted by the appropriate District Registrar to the designated Tournament Registrar for each National Tournament no later than March 1. Team credentials for at-large or teams participating in the last weekend of district tournaments must be submitted to the designated Tournament Registrar for each National Tournament no later than 24 hours after the completion of the District Tournament or notification of selection as an at-large team. For Youth Tier I and Girls Tier I/II teams participating in the RMD tournament, I would like to have all documents by February 10, 2025, if possible but no later than February 17, 2025.

NOTE: Coaches must be added to the Official Roster (1-T) at least seven (7) days prior to the National Championship Tournament beginning. Any request to add a coach after this deadline requires extenuating circumstances and must be submitted to the National Championship Appeal Committee. Approved locker room monitors must be identified at least seven (7) days prior to the National Championship Tournament beginning.

# Important Reminders

## Tier I Youth and Girls Credential Date

### Head Coach Check-In

Head coaches must check in with the National Tournament Director one (1) hour prior to their team's first game at the rink in which the game is being played. All coaches must show government-issued photo identification to the Tournament Director on site prior to being on the bench. Head coaches must verify their team's roster and sign the game scoresheet in the tournament office at least 15 minutes prior to all subsequent games.

### Locker Room Monitor Check-In

Locker room monitors must check in with the National Tournament Director one (1) hour prior to their team's first game at the rink in which the game is being played to receive a credential. All locker room monitors must show a government-issued photo identification to the Tournament Director.

## Important Reminders

### Emergency Back Up Goalie (EBUG)

For any teams that need an Emergency Back Up goalie (EBUG), the team will need to submit an appeal to the National Championships Appeals Committee. Registrars cannot add EBUGs to the roster that were not on the roster prior to December 31 and/or did not meet the game count requirements. Teams that played all season with one (1) goalie are expected to go to Nationals with one goalie. To request an EBUG, a team must submit the following to the team's district registrar:

Provide proof/explanation of extenuating circumstances to show why a team with two (2) goalies now only has one (1) or a team with one (1) goalie and now have no goalie (i.e. medical note);

Provide the name, team, program, and level of the goalie the team would like as an EBUG. EBUGs must be in the same age classification as the team. EBUGs should be from the same affiliate, at the same or lower level of play, and from a team that is no longer competing at an affiliate, district, or national championship.

The district registrar will review the documentation to confirm the extenuating circumstance and that the EBUG requested by the team conforms to the above. If it conforms to the above, the registrar will submit it to the National Championship Appeals committee, along with their recommendation for this specific request. If approved, EBUGs will only be allowed to play in affiliate, district, or national championships or games leading thereto when it is shown that the team's other goalie on the roster is unable to play.

# Important Reminders

## Emergency Back Up Goalie (EBUG) Cont...

If the team only has one (1) goalie and a situation arises during an affiliate, district, and/or national tournament where the goalie becomes unable to continue, the team will be expected to dress a skater as a goalie or finish the game with six (6) skaters. For the remaining games, the onsite tournament registrar can submit the above request for an EBUG. If an EBUG is needed, and it's not logistically feasible for the team to supply one, the team can inquire with the host to see if one is available locally. A local EBUG must be approved by the tournament registrar.

# Important Reminders

## Athletic Trainers

Certified Athletic Trainers (ATCs) shall be allowed to work with their teams at State/Affiliate, District and/ or National Championships if the ATC is on the team roster by December 31 (no substitutions may be made after this date). The ATC must be a registered volunteer member of USA Hockey, have current SafeSport Certification valid through the tournament, and have passed a USA Hockey NCSI background screen. The program must provide proof of the following to USA Hockey's Manager of Player Safety seven (7) days prior to the State/Affiliate, District and/ or National Championship:

Current license for ATC to practice in the state the program is located;  
Current NATABOC certification for ATC;

At the tournament the following guidelines must be followed by the ATC:

ATC must check in with on-site medical staff prior to each game played to identify/introduce themselves.

ATCs are not allowed on the bench during the games. They can have access to the bench or ice surface if needed to attend to their players for treatment.

ATC must work in conjunction with the on-site medical personnel to ensure the best care for the players, should injury occur, including return to play decisions. The on-site medical staff will have final approval if players return to the ice.

Any injuries or playing status must be on record with the on-site medical personnel and tournament staff.

Answer: Yes
