

2020 Dragon Youth Football Season Waiver

RELEASE FORM: We, the parents, do hereby grant permission for him/her to participate in the Dragon Youth Football (DYF) Season and acknowledge the fact that he is physically able to participate in activities. The undersigned hereby releases DYF from any and all claims, demands, and causes of action whatsoever in any way growing out of or resulting from the participation in the football season, which begins on September 7, 2020 and ends December 5, 2020.

ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY RELATED TO CORONAVIRUS/COVID-19: The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. DRAGON YOUTH FOOTBALL has put in place preventative measures to reduce the spread of COVID-19; however, DRAGON YOUTH FOOTBALL cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending DRAGON YOUTH FOOTBALL events could increase your risk and your child(ren)'s risk of contracting COVID-19. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending DRAGON YOUTH FOOTBALL events and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at DRAGON YOUTH FOOTBALL events may result from the actions, omissions, or negligence of myself and others, including, but not limited to, DRAGON YOUTH FOOTBALL officials, employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at DRAGON YOUTH FOOTBALL events or participation in DRAGON YOUTH FOOTBALL programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless DRAGON YOUTH FOOTBALL, its officials, employees, agents, and representatives, and any schools or facilities where DRAGON YOUTH FOOTBALL events are held, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating to COVID-19. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of DRAGON YOUTH FOOTBALL, its officials, employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any DRAGON YOUTH FOOTBALL event.
