STATE LAW REQUIREMENTS

_____ Our association acknowledges receipt of information regarding the Pennsylvania State Background Clearance Law (Act 153 of 2014), which requires comprehensive criminal and child abuse background checks for employees and volunteers who have routine and/or direct contact with children.¹

_____ Our association is aware of state laws requiring certified cardiac and concussion training² for all coaches of interscholastic sports teams.³

USA HOCKEY/MIDAM REQUIREMENTS

_____ We understand that the USA Hockey insurance policies are comprehensive and cover the membership ONLY when members/teams are playing in sanctioned events authorized by USA Hockey and/or playing against other teams with an approved USA Hockey roster. Other off ice activities should be discussed with the USA Hockey Risk Manager (Mark Zukowski – mmzukowski@ehd-ins.com) to verify the scope of exposure and any potential coverage gaps that may be present due to the activities being performed. All contracts signed between associations and vendors should also be vetted with the USA Hockey Risk Manager to be in compliance with USA Hockey's insurance policies.

_____ By appearing on a USA Hockey Roster (per USA Hockey registration and rostered on a PIHL-registered team), all individuals consent to be a part of all audio and video productions either produced by the Pennsylvania Interscholastic Hockey League or sanctioned by the Pennsylvania Interscholastic Hockey League, without requiring compensation. The PIHL has authority to produce -- or authorize production of -- the name, image, and/or likeness of all players and coaches for use on websites, social networks, publications, and similar media at the sole discretion of the PIHL. Our association understands it is our responsibility to inform any of our individuals wishing not to consent to this agreement to contact the PIHL Commissioner's Office.

_____ Our association and its members are aware that USA Hockey has ZERO TOLERANCE for abuse and misconduct. The SafeSport Handbook includes the various policies that apply to all USA Hockey Member Programs. In addition to these policies, the SafeSport Handbook includes information about the available and required training of USA Hockey and its Member Programs' employees, volunteers, administrators, coaches, parents and players on recognizing and reducing circumstances for potential abuse to occur; information on USA Hockey's Screening and Background Check Program; the availability and procedures for any person to report suspected abuse or misconduct (including protections from any retaliation or repercussions for such reporting); the procedures and means by which USA Hockey and its Member Programs should respond to allegations of abuse and misconduct; and how USA Hockey and its Member Programs will monitor and supervise the SafeSport Program to help ensure its effectiveness.⁴

- _____ Our association is in compliance the SafeSport Code adopted by the Center for SafeSport and the USA Hockey SafeSport Handbook and have provided a signed agreement with the Mid-American Affiliate of USA Hockey.
- _____ Our association is aware of the new USA Hockey rules passed at the recent USA Hockey Annual Congress for the 2021-2022 season.⁵ The rule changes, USA Hockey Zero Tolerance Policy and Rule Emphasis & Standards will be properly communicated to our players, coaches and families in coordination with the PIHL Sportsmanship Initiative.⁶
- _____ Our association is aware that all sports are associated with the risk of sustaining a concussion, including playing, officiating or participating in ice hockey. It is important that all participants and parents learn about concussion prevention, recognition, treatment and return to play. USA Hockey provides all participants with information and educational materials about concussions, including the risk of sustaining a concussion, how to minimize these risks, concussion signs and symptoms, and USA Hockey's program for returning to play following a concussion. If a USA Hockey participant reports one or more symptoms of concussion after a blow to the head or body, s/he should be kept out of practice, play or training immediately and referred to a health care professional with experience in concussion management. - _____ Our association has been informed that guidance from USA Hockey requires all volunteers – including penalty box attendants, board members, scorekeeper and timesheet – are required to have the proper background clearances. Our association is responsible for compliance within our association.
