1. Our first Roundup Country Rodeo Bible Camp will be held at the Roundup Fairgrounds in Roundup, Montana, Thursday and Friday, June 25th and 26th, 2026 for ages 10 to 18.
2. The Cost for each applicant is \$25 for the two days. **Registration is due by May 31st**, to insure your registration and help us properly plan for the event. Payment is due upon arrival. Please send your application in ASAP!
3. You must provide your own horse and gear to participate in this camp. Western attire is required.
4. Check in will be at the Roundup Fairgrounds, (follow **2<sup>nd</sup> Ave.** East to **4-H** Road and cross the river) June 25th before 9:00am. Camping will be allowed on the Fairgrounds. Participants will be required to spend the night and attend activities on both days.
5. Meals will be provided for the participants, but not for their families: Lunch and Dinner on Thursday, and Breakfast, Lunch and Dinner on Friday.
6. Be sure and invite your family and friends to our "Cowboy Church" on Friday evening, in the Grandstand, at 6pm.
7. Please read all the enclosed information carefully. All forms must be filled out completely to participate in the camp.
8. A liability waiver signed by participant and guardian, and notarized is required. A notary will be present on sign-in day.
