

**Hibbing Youth Baseball (HYB)
COVID-19 Return-to-Play Waiver**

Hibbing Youth Baseball has limited operations due to the COVID-19 pandemic. This is a waiver to allow players to participate in Hibbing Youth Baseball activities under certain conditions.

In consideration of allowing the below player to participate in any way in the activities and/or being permitted to enter any related premises, each of the undersigned, on behalf of themselves, their executors, administrators, heirs, next of kin, successors, personal representatives and assigns, hereby voluntarily agree that:

- a. The player and parent or guardian agree to abide by the Hibbing Youth Baseball COVID-19 Safety Guidelines.
- b. The player and parent or guardian agree that if at any time they believe something to be unsafe, it will be brought to the attention of a Hibbing Youth Baseball representative. Representatives include, but are not limited to, board members, coaches, and assistant coaches.
- c. The player and parent or guardian assume full responsibility for the risk of bodily injury, death or property damage, due to the actions or negligence of Hibbing Youth Baseball, their board members, officers, employees, volunteers, representatives, and agents (hereinafter, "Releasees") or otherwise, while in or upon the premises, use of equipment or participating in activities. The minor and parent or guardian recognize and understand that there are risks and dangers associated with participating in the activities. Further risks and dangers may be caused by the actions or negligent failure to act of the Releasees and others. All of the risks and dangers associated with participating in the activities, entry into the premises, or use of equipment are assumed and notwithstanding.
- d. The player and parent or guardian assume full responsibility for the risk of illness, hospitalization, or death due to direct or indirect contact with individuals who have or may have been exposed to and/or diagnosed with one or more communicable diseases, including but not limited to COVID-19, or other medical conditions, diseases, or maladies, and/or any mutation or variation thereof.
- e. The player and parent or guardian waive, release and discharge the Releasees from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to the player, parent or guardian and their estates.
- f. The player and parent or guardian indemnify, save and hold harmless, the Releasees and each of them personally from and against any and all liabilities, loss, damage, causes of

actions and claims arising from the minor's participation in the activities identified herein or presence in premises, whether caused by the releases, the minor, or otherwise.
