



ASSUMPTION OF RISKS, RELEASES AND WAIVERS OF LIABILITY

1. As to Athletic Activity:

In enrolling at, or participating in, or being a spectator at events associated with the Wayne Hockey Club, the undersigned understands that he/she/they are attending the programs voluntarily and at his/her/their own risk. The Wayne Hockey Club shall not be liable for any damage whatsoever arising from any personal injury, death or property loss sustained by the undersigned.

The participant and/or the participant's parent and/or guardian (collectively, the undersigned) acknowledge that the game of hockey is inherently risky and that participating in or being a spectator at a game of hockey carries the risk of serious injury, even while not actively engaged in play on the ice.

The undersigned assume full responsibility for all injuries and damages, including death, which occur in or about the premises and while participating in any programs thereon including as a spectator. The undersigned do hereby fully and forever release discharge and hold harmless the Wayne Hockey Club from any and all claims, demands, damages or rights of action, present or future resulting from any person's participation in any programs, as a spectator on behalf of themselves or their minor children.

In addition, the undersigned agree to follow the rules of conduct and play set by the Wayne Hockey Club. Failure to do so may result in suspension from any participation or expulsion from the premises.

2. As to COVID-19:

The participant and/or the participant's parent and/or guardian (collectively, the undersigned) acknowledge that this Assumption of the Risks, Releases and Waivers, is being contemplated and executed at the time of the COVID-19 Pandemic and that the

presence of and/or the participation by the undersigned gives rise to the risk of serious illness and death from this disease. The undersigned also acknowledge that much is unknown about COVID-19 including how it spreads. At this time, there is no known cure. The parties also acknowledge that infection from this disease could come before, during or after participating in this program.

In participating in, or being a spectator at events, the undersigned understands that he/she/they are attending the programs voluntarily and at his/her/their own risk for exposure to COVID-19. The Wayne Hockey Club shall not be liable for any damage whatsoever arising from any personal injury, death or property loss related to COVID-19 sustained by participant.

The undersigned assume full responsibility for illness and damages, including death, which occur in or about the premises and while participating in any programs thereon related to COVID-19. The undersigned do hereby fully and forever release discharge and hold harmless the Wayne Hockey Club from any and all claims, demands, damages or rights of action, present or future resulting from any person's participation on behalf of themselves or their minor children related to COVID-19.

I, the undersigned parent or guardian/participant do hereby grant authority to the Wayne Hockey Club to make any decision concerning medical assistance or hospital care in the event of an accident or illness during my absence.

The undersigned hereby expressly acknowledge that they have read and understood the above statements of assumption of the risks, releases and waivers and that they have freely and voluntarily executed the same.
