We knowingly and freely assume all such risks on behalf of our self and/or our player, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for our self and/or player; and,

We willingly agree to comply with the stated and customary terms and guidelines for participation (see SYHA COVID Preparedness Plan). If, however, we observe any unusual significant hazard during our presence or participation, we will remove our member(s) from participation and bring such concerns to the attention of the nearest official immediately; and,

We will not participate in any programs and related events and activities if I have any reason to believe we may be carrying COVID-19, if we have an elevated temperature, or if we are feeling ill: and,

We acknowledge that we are aware that there are risks to our self and/or player of exposure to directly or indirectly arising out of, contributed to, by, or resulting from an outbreak of all communicable disease, including but not limited to, Coronavirus Disease (COVID-19).

We indicate our agreement to this release and waiver of claims.
