Bayou (BY)		Before Jan 15 negotiated by club/guardian AFTER Jan 15 - Feb 15 need approval by region
Carolina (CR)	tryout any time after GJNC; cannot commit until 09/01	extenuating circumstances, commissioner approval, cannot play REGION sanctioned events if have already played at other club
Chesapeake (CH)	5 DAYS	1-after the probation period 2-they have not played for the team they have already committed to BUT they must reimburse the club for all registration fees already paid
Columbia Empire (CE)	Fall tryouts only / no waiting period	Before Dec 15 can sign with a team in Feb AFTER Dec 15 can't sign until after regionals
Delta (DE)	none	once signed stay with club until junior nationals

Excelsior Empire (XL)	Signins is 5 days after TO begin	Player can transfer in writing to both clubs and region and then must be approved by the commissioner; any transfer requests after 02/01/25 the BOARD must approve the transfer
Florida (FL)	clubs' discretion but cannot offer until 09/01	extenuating circumstances, commissioner approval, cannot play REGION sanctioned events if have already played at other club
Garden Empire (GE)	72 HOURS	extenuating circumstances ONLY
Gateway (GW)	Summer before HS and Fall trouts after HS / Sun 7pm after TO open (Fri 5 pm)	Commitment - Jr Natls
Great Lakes (GL)	as soon as first tryout date (1st Sat after Nationals)	Can't transfer after play in first event / if before then up to releasing club
Great Plains (GP)	Aug 1, no waiting period	Aug 1 - G/BJNC
Gulf Coast (GC)	Immediately following school vb season / 7 day period to accept	complete financial agreement
Heart of America (HA)	<b>Signing is 7 days after tryouts begin</b>	commissioner approval once clubs agree; all in writing
Hoosier (HO)		mutual agreement and approved by region commissioner
Intermountain (IM)	Tryout anytime after current season is over / no signing policy or waiting period	mutual agreement and approved by region commissioner
Iowa (IA)	Immediately following JNC until HS starts, no waiting period but if a club makes the offer it stands until HS state tourney ends. Fall: 48 hrs	transfer after G/BJNC

North Texas (NT)	Tryouts can begin in May after NT Reg / Written acceptance thru OCS July 8th	
Northern California (NC)	Signins is 5 days after TO begin	
Ohio Valley (OV)	72 HOURS	
Oklahoma (OK)	Signing is 10 days after tryouts begin	before Dec 31 w/o penalty but financial agreements met first / no transfer after Dec 31
Old Dominion (OD)	After completion of B/GJNC / no waiting period	no transfers once player has played at USAV & Region sanctioned event
Palmetto (PM)	tryout any time after GJNC; cannot commit until 09/01	clubs' discretion
Pioneer (PR)	Fall tryouts only / 48 hour waiting period	clubs' discretion BUT Region MUST be informed
Puget Sound (PS)	summer before HS / fall after HS / 48 hour waiting period	financial agreement / restriction for Qs/Cs
Rocky Mountain (RM)	TO: After G/B JNC // B: incumbent 26 Jul; new 29 Jul // G: incumbent 22 Jul; new 23 Jul	no transfer once first tournament of season is held by RMR
Southern (SO)	any time after JNC / no waiting period
