In consideration of my participating in the activities offered by the Cleveland Skating Club (the "Activities"), I, the undersigned, agree and represent as follows:

I or my child is qualified, in good health, and in proper physical condition to participate in the Activities.

I agree to abide by all rules, guidelines, policies, or codes of conduct that the Cleveland Skating Club may implement. Even so, I fully understand that the Activities involve risks of serious bodily injury, including permanent disability, paralysis, and death, which my own action, or inactions, those of others participating in the Activities, the conditions in which the Activities takes place, or the negligence of the "Releasees" defined below, may cause; and that there may be other risks either not known to me or not readily foreseeable; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the Activities. If I believe any conditions are unsafe, I will immediately discontinue participation in the Activities.

On behalf of myself, my heirs, executors, administrators, successors and assigns, I release, discharge, and covenant not to sue the Cleveland Skating Club, its directors, officers, administrators, sponsors, volunteers, agents, employees, staff, instructors, trainers, other participants, owners and lessors of premises on which the Activities take place (each considered one of the "Releasees") from all claims, demands, rights of action, causes of action, losses or damages of any kind, whether known or unknown, anticipated or unanticipated, because of injury including death, illness, disease, accidents, medical costs or damage to property caused or alleged to be caused directly or indirectly from participating in or otherwise resulting from or arising out of the Activities to the fullest extent permitted by applicable law, even if such claims, demands, losses or damages result, in whole or in part, from any action, inaction, negligence or otherwise, of the Cleveland Skating Club or any other party. I assert that my participation in the Activities is voluntary and that I knowingly assume all such risks.

I further agree that I intend that the foregoing assumption of risk agreement to be as broad and inclusive as the law of the State of Ohio permits and that if any portion thereof is held invalid, I agree that the balance shall, notwithstanding, continue in full legal force and effect.

I accept financial responsibility and agree to compensate the Cleveland Skating Club for any incident, claims or actions for damages I inflict on the property or properties of the Cleveland Skating Club.

BEFORE SIGNING BELOW, I HAD AN OPPORTUNITY TO READ THIS DOCUMENT AND UNDERSTAND THAT IN EXCHANGE FOR BEING PERMITTED TO PARTICIPATE IN THE ACTIVITIES I OR MY CHILD AM ASSUMING ALL RISKS RELATED TO OR ARISING OUT OF THE ACTIVITIES. I UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING BELOW AND HAVE SIGNED FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCES OF ANY NATURE, AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY THE LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
