

Dowling Catholic Basketball Club Participation Agreement and Release

I understand and agree that during the novel coronavirus pandemic (COVID-19), to participate in DCBC activities I must agree to the following terms and conditions.

Acceptance of Risk, Release and Indemnification:

COVID-19 is a highly infectious, potential life-threatening disease declared by the World Health Organization to be a global pandemic. There is no current vaccine for COVID-19. Due to the highly contagious nature of the virus, this means that contact with others, or contact with surfaces that have been exposed to the virus can lead to infection. Additionally, individuals who may have been infected with COVID-19 may be asymptomatic (without symptoms) for a period of time or may never develop any symptoms at all. Because of the contagious and sometimes "hidden" nature, it is currently very difficult to control the spread of COVID-19 or to determine whether, where, or how a specific individual may have been exposed to the virus. I am fully aware that there are a number of risks associated with participation in DCBC activities during the COVID-19 pandemic including, but not limited to: I could contract COVID-19 which could result in a serious medical condition or even death.

In consideration for being able to participate in DCBC activities during the COVID-19 pandemic, I, for myself, my heirs, assigns, and next of kin do hereby release and forever discharge, indemnify, and hold harmless DCBC, its board, employees, and players from any liability for losses, damages, injuries or costs, including, but not limited to: those described in this document that may arise out of or that may in any way be related to such participation, whether caused by the negligence of the above mentioned parties or otherwise.

By signing this agreement, I acknowledge the contagious nature of COVID-19, the fact that it can be difficult to identify in individuals, and the inherent risk of exposure during participation to those who may be infected with COVID-19. I voluntarily assume that risk that I may be exposed to or infected by COVID-19 by participating and that such exposure or infection may result in personal injury, illness, permanent disability, and/or even death. In submitting this release, I acknowledge and represent that I have reviewed it and understand what it means and that I have signed this release with full consent. This release shall be binding upon my heirs, executors, administrators, and assigns.

Agreement to Terms and Conditions

I agree that I am personally responsible for my safety and actions while participating in DCBC activities during the COVID-19 pandemic. I agree to comply with all policies and rules, including but not limited to all DCBC guidelines, signage and instructions. There may be additional guidelines that Ignit does/does not request of players prior to entering and during use of their facility. I acknowledge and agree that if I fail to follow policies and rules, I may/will be asked to leave and further participation in DCBC activities may be suspended. I expressly acknowledge and agree that, while DCBC will do its best to reduce the chance of transmission of COVID-19, DCBC has not assumed or undertaken any obligation to guarantee my health.

I understand this authorization is voluntary. That is, I can refuse to agree to the terms of this agreement, but if I do refuse to agree to such terms, I will not be allowed to participate in DCBC activities.
