# USL Championship Playoffs presented by Terminix Bracket Challenge

The USL Championship Playoffs presented by Terminix Bracket Challenge (the “Sweepstakes”) is sponsored by United Soccer League, LLC (“Sponsor” or “USL”) and governed by these official rules (the “Official Rules”). ## **SWEEPSTAKES PERIOD**

Beginning on October 26, 2025 at 12:30 AM ET and ending on November 1, 2025 at 6:30 PM ET.

## **ENTRANTS**

Individuals who are eighteen (18) years of age or older may enter. Employees and immediate families of employees of the Sponsor and its member clubs are not eligible to enter. Sponsor reserves the right to verify the eligibility of each entrant (“Entrant”).

## **HOW TO ENTER**

You can enter the Sweepstakes by making the following selections:

- One (1) winning team for each of the 15 matches in the USL Championship Playoffs

Each entrant must then enter each of the following data points to be eligible for prize.

- First Name
- Last Name
- Email
- Date of Birth
- Zip Code
- Favorite USL Club

Maximum limit of one entry per Entrant per email address, regardless of method of entry. All entries must be received by the end of the Sweepstakes Period to be valid. Incorrect or incomplete entries are void. Any attempt to obtain more than one (1) entry by using multiple/different email addresses,

identities, registrations or logins, or any other methods may void the entries and Entrant may be disqualified from the Sweepstakes. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, sweepstakes entry services) will void all entries by Entrant. In the event of a dispute as to any online entry, the authorized account holder of the email address used to enter will be deemed to be the Entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder.

### **WINNER SELECTION**

Brackets will be scored based on the scoring process set forth below:

- One (1) point for each correctly predicted match

At the conclusion of the Tournament, Entrants scores will be calculated, and prizes will be awarded as described below. In the event of a tie, ties will be broken in the following order:

1. Correctly guess the tournament winner
2. Number of points scored in Conference Finals Round
3. Number of points scored in Conference Semifinal Round
4. Number of points scored in Conference Quarterfinal
5. Earliest date/time of Prediction submission

Odds of winning will depend on the total number of eligible entries received for the applicable drawing. Winners will be notified by Sponsor via email on or about December 2, 2025. Each Entrant is responsible for monitoring his/her email account for prize notification and receipt or other communications related to this Sweepstakes. Decisions of the Sponsor in the selection and determination of prize winner and all matters relating to this Sweepstakes are final and binding.
