I. Call to Order

II. Report of Officers

A. Presidents Report

- a) Jana motioned to approve a new vendor for jerseys and hats, Jason seconded the motion. All in favor. 0 opposed. Motion for a new uniform vendor passed.

D. Capital Improvement Project: Jacob Vincik provided the board with quotes for all capital improvement ideas discussed at the July meeting.

- a) Josh Cambron motioned to approved purchasing new brooms, a new rake, a new ice machine, and 40 sets of new catcher's gear. Jason seconded. All in favor. Motion approved.
- b) Jacob Vincik motioned to approve purchasing new pitching mounds for the 13 and up divisions. 9 votes in favor. 2 abstentions. Motion approved.
 - a. An addendum to by-laws will need to state that metal cleats will not be allowed on new mounds.

E. Batting Cage issues: It was brought to our attention that people keep taking the L screens out of the batting cages and not putting them back. One broke this week when it was moved to field 5.

- a) Jason to buy L screens for fields 5 and 6.
