Miracle League Update:

- Executive Board proposes that we financially support Miracle League to allow them to break ground yet this fall with the intention of finishing next summer
 - Executive Board Vote: Any shortfall in fundraising next spring - PLAY would back their financial needs with the expectations to be paid back with future fundraising
 - Anonymous donor still on track to pay \$75K a year for the next 10 years
- If we did not invest in ML - what would PLAY be using those funds for?
 - We currently do not have a “big-vision” with no buildings/land available and turf too expensive
- Brent made a motion to approve backstopping the funding for the Miracle League. Tommy 2nd the vote - APPROVED at 7:35am.
