Boys and Girls – July 15-19, 2019 at Keene ICE

Open to beginning, youth and experienced hockey players ages 6-18.

What you can expect On-Ice:

You will receive outstanding on-ice instruction each and every day. No other camp in the area can offer the experience and expertise for your hockey development. Campers will receive approx. 26 hours of ice time for the week, working with some of the best on-ice hockey coaches in the region.



On-Ice camp director is Chris Davidson, is currently the General Manager for Hockey Operations for the Seacoast Spartans Hockey Club in Exeter, NH. Previously, Chris was the Men's Hockey coach at Vermont Academy, and prior to that was the Men's Head Hockey Coach at St Michael's College in Vermont, where his team won the NCAA National Championship as a player. He has coached 16 players who have signed Professional Hockey contracts and numerous All American players.

Chris has invited several current college and prep school coaches to work or speak at the camp, as well as several current prep and college players.

What you can expect Off-Ice:

Campers will receive approximately 5 hours of off-ice dry land activity, which will supplement the on-ice workouts.

Off-Ice camp director Mike Atkins, who is currently the AD at Keene HS, has 25+ years of strength and conditioning experience. He is a Certified Strength Coach and a Certified Personal Trainer by the NSCA, as well as a Certified Olympic Lifting coach by the US Olympic Committee. Previously, he was the strength coach working with Coach Shawn Walsh at the University of Maine Men's hockey team, as well as being the strength coach at the prep school level at Northfield Mt Hermon School in Massachusetts. He has worked with numerous prep, DI and DIII college, and several NHL hockey players. He has the expertise and experience to help players with their off-ice development.

What you can expect for the week:

Campers will finish the week with a solid foundation for the rest of the summer as they train to prepare for their upcoming fall and/or winter season. Campers will receive the equivalent of 3-4 weeks of regular season ice time over the span of 5 days. This is a true value for the camp price of **\$399**. The five day total of approximately 25 hours of on-ice time is the equivalent of 3 weeks or regular season practice ice time.

CANCLLATION POLICY

Please keep in mind that our cancellation policy is in place, due to the fact, that we prepare each individual camp, with the projected number of sign-ups. We try to insure fairness to all who wish to attend our Keene Development Hockey Camps. Our overhead costs, with staffing, ice, travel, etc. are based on the number of campers signed up for that particular camp. This is the basis for our cancellation policy. **Refund requests must be submitted no later than 30 days after the last day of camp expires.**

- Cancellations before May 1, 2018 will receive a cash refund less the non-refundable 50% deposit.
- Cancellations after May 1, 2018 will receive a 50% credit towards a future camp – no cash refunds. All original deposits are non-refundable.
- Failure to attend a camp/clinic without notification to KDHC, Inc. will result in no refund or credit.
- If a camper becomes sick or injured at a camp/clinic or before a camp/clinic, 50% of the unused paid portion of the camp/clinic tuition will be returned as a credit to your account for a future camp/clinic. A doctor's note is required.
- Keene Development Hockey Camp, Inc. cannot provide refunds for cancellations due to unforeseen acts of God, including facility damage/closing complications or weather related rink/facility cancellations. These are highly unlikely to occur, but in the event it does, we will issue credit vouchers prorated for the remainder of the affected program.
- If Keene Development Hockey Camp, Inc. cancels for any other reason not specified above we will offer you a full refund.
- Keene Development Hockey camp, Inc. reserves the right to cancel or change camps/clinics, dates, times or locations.
- Keene Development Hockey camp, Inc. has a zero tolerance policy with respect to uncontrollable behavior, bullying, hazing, alcohol, tobacco, drugs and controlled substances, weapons of any kind, or any other activity which we deem illegal or not in conformance with KDHC standards. If a camper is expelled due to any of the above circumstances, no refunds will be given.
