Vice President Report

- **Inventory Project-** Volunteer efforts were made by Coaches and Board Members to gather and inventory all the cheer program gear, evaluate the quality of the item and determine next steps for potential replacement and storage.
- **Competition Pom & Sign Purchase-** After inventory it was decided that additional poms may need to be purchased for the competition side of the program due to growth on the sideline side, and potential overlap of use. Competition Director Brown has been investigating pricing for poms and VP Stewart has requested all Competition Coaches to provide what they need for poms. Will likely order after Choreography next week.
- **Season Schedule Update-** The fall practice schedule has been sent out to all Competition cheer families.
