Hello Everyone,

Effective Friday October 9th, Baierl Ice Complex can operate at a maximum of 20%-person capacity

Below is a summary of how the new guidance from the Governor effects Baierl Ice Complex:

- We can play games 5 on 5 with full rosters!
- 2 parents per player (and younger siblings only if necessary) may attend games.
 - Parent coaches or parents serving as game personnel does not permit more people to attend.

This is where I need your help:

- Parents can only enter the facility 5 minutes before the scheduled start time of their players' game.
- Parents must exit the facility immediately after the game.
 - Unless your players are in ADM, please explain they must meet you outside.

Arriving at Baierl Ice Complex

- If you or anyone in your family has any COVID-19 symptoms, or if they are not feeling well, we ask that you please stay home. Do not visit the Baierl Ice Complex.
- If you have a weakened immune system, or living with someone who is considered vulnerable, we recommend that you please stay home.
- The PA Health Department recommends that people take precautions while traveling and require quarantine for 14 days after returning out of state. For details visit www.health.pa.gov
- We require that all guests practice social distancing by staying at least 6 feet away from other customers not in your group.
- The Governor and local health department orders require all patrons to wear masks while on the premises. Exempted are those who have a medical condition that precludes them from wearing a mask (including children under the age of 2 years per CDC guidance).

COVID-19 Case Notification

- If you have been diagnosed with COVID-19, please contact your organizations designated Pandemic Officer or Team Member.

Warning: An inherent risk of exposure to COVID-19 exists in any public location where people are present; Therefore, we cannot guarantee you will not be exposed during your visit. COVID-19 is an extremely contagious disease that can lead to severe illness and death and people who show no symptoms can spread COVID-19 if they are infected. According to the CDC, older adults and people of any age who have serious underlying medical conditions might be at higher risk for severe illness from COVID-19. FACILITY SAFETY POLICIES

MASKS

- All persons must properly wear a mask at all times while inside the facility.
 - The mask must fully cover the nose and mouth.
 - Exceptions: Players on-ice, coaches on-ice during practices, referees during games, children age 2 and under, and individuals who cannot wear a mask specifically due to a medical condition
- Players must continue to wear a mask while in the locker rooms and surrounding areas.
 - Players who use the lobby area to dress or have their skates tied must properly wear a mask during this time. We highly recommend using your assigned locker rooms.
 - Players wearing a helmet do not need to wear a mask when migrating between the locker room and the ice surface.
- Coaches must continue to wear a mask while not on the ice surface, including in the locker room, in the locker room hallways, and on the benches.
 - Coaches are permitted to remove masks once on the ice surface for practice.
 - Coaches should encourage safe distancing and avoid close gatherings on the ice.
- Referees must continue to wear a mask while not on the ice surface, including in the locker room and surrounding hallways. Referees are permitted to remove masks once on the ice surface.
- Parent/guardian, team manager, and game personnel (medic, scorekeeper, etc.) must keep masks on at all times while inside the facility.

ARRIVAL TIMES

- Players, coaches, managers, and referees are only permitted to enter the facility within 30 minutes prior to the scheduled start of practices or games (scheduled event).
 - These individuals must proceed directly to their locker room areas upon entering the facility and remain in that area as much as possible.
- Game personnel may only enter the facility within 10 minutes prior to the scheduled start of the game.
 - These individuals must proceed directly to their applicable locations – such as the scorer's box – upon entering the facility.
- Players requiring assistance due to a medical condition may be accompanied by one parent/guardian while inside the facility, as long as a mask is worn by the parent/guardian and proper social distancing is established from others within the facility.

PARENTS/GUARDIANS with players – Ages 8 and under (ADM)

Practices

Only one parent/guardian per participant will be allowed:

- If siblings accompany parents in the facility, they must stay with the parent at all times.
- Players are encouraged to arrive dressed or partially dressed.
- Parent/guardian can enter the locker room to tie/untie skates and help their child get dressed/undressed.
- Players should wait in the locker room with their parent/guardian with their mask on until the start time of practice and go directly to the ice surface. Parent/guardian should either exit the facility or go to the appropriate rink bleacher area. Please make sure you keep your mask on and follow social distancing guidelines. Upon the end of the practice or game the parent/guardian should meet their player in their locker room and exit the facility as soon as possible.

Games

Two parents/guardians per participant will be allowed:

- One parent/guardian per player may enter with their child and the other parent/guardian should enter 5 minutes before game time and must go directly to the designated rink.
- Family members must sit together, wear masks and socially distance from other parents/guardians. Siblings must stay with parents at all times
- Parents are not to congregate inside the facility.
- After the game, one parent/guardian (and siblings) must immediately exit the facility. The other parent can help their player get undressed and exit the facility together.

PARENTS/GUARDIANS with players – Ages 9 to 18

Practices

- One parent/guardian is permitted to attend practice with their child. Parents should go directly to the designated rink bleachers.
- Please wear your mask and social distance from other people.

*1 In-House parent (Ages 9-12) can help their player with their skates (13 & 14 yr. old are expected to dress on their own).

Games

- Two parents/guardians per player may enter 5 minutes before game time and must go directly to the designated rink bleachers. Siblings must stay with parents at all times.
- Parents are not to congregate inside the facility.
- No parent shall enter a locker room nor the surrounding hallways.
- Parents/guardians must immediately exit the facility after the game and meet the player outside.

*1 In-House parent (Ages 9-12) can help their player with their skates (13 & 14 yr. old are expected to dress on their own).

PRACTICE AND GAME FORMAT

Shared Ice Practices - 2 Teams (*Updated)

- Shared Ice Practice can resume as previous season(s). Full ice warm-up with both teams

Each rink has carts with bumpers to divide the ice. Please notify the front desk prior to your practice so the Zamboni driver can put the cart on the ice. Please wait until the Zamboni driver finishes the ice cut before putting bumpers on the ice.

Games

- Games will be permitted to played 5 vs 5 with full rosters including coaches and officials. Coaches and off-ice game officials are required to wear a mask at all times.

Live Barn Streaming Service

Parents/guardians and spectators are encouraged to watch their child or acquaintance outside the building or at home (use the Baierl discount code: **311b-815c**).

COVID-19 POSITIVE - PLAN OF ACTION

If Baierl Ice Complex is contacted by a patron stating that they are feeling ill with any COVID-19 symptoms or has been diagnosed with COVID-19, Baierl Ice Complex will take the following actions:

Identify which organization the patron is with and work to determine:

1. When was the patron was in the facility?
2. What areas did the patron visit?
3. Who was the patron in direct contact with?
4. Notify all patrons that had direct contact with infected person(s) while keeping their identity confidential.

Notify Health Officials and Close Contacts

- In accordance with state and local privacy and confidentiality laws and regulations, youth sports organizations should notify [local health officials](#), youth sports program staff, umpires/officials, and families immediately of any case of COVID-19 while maintaining confidentiality in accordance with the [Americans with Disabilities Act \(ADA\)](#)[external icon](#) and other applicable laws and regulations.
- Work with [local health officials](#) to develop a reporting system (e.g., letter) youth sports organizations can use to notify health officials and close contacts of cases of COVID-19.
- Advise those who have had [close contact](#) with a person diagnosed with COVID-19 to stay home and [self-monitor for symptoms](#), and to follow [CDC guidance](#) if symptoms develop.
