



## Player and Parent Financial Agreement 2025/2026

I agree to participate with the FreeState Volleyball Club during the 2025-26 Season. Player and Parent agree to pay a **\$1000.00** Initial Deposit per player to FreeState Volleyball Club upon acceptance of their team placement to hold their roster spot for the 2025-26 club season, which will be applied to their total team fees of **\$2150.00** for the season. Player and Parent also understand that the \$1000.00 deposit is non-refundable should the player or parent change their mind and opt not to participate in the program. The FreeState Volleyball Club guarantees a roster spot to the Player and Parent for the 2025-26 season.

**Player and Parent understand and agree to pay the total amount per player for team dues according to the team the player is assigned to.**

- Parent and Player agree to pay the total fees due on time as laid out in the payment agreement. Player and Parent understand that all payments must be received by the FreeState Volleyball Club on the agreed upon date for the payment to be considered on time. Player and Parent understand there is a \$25.00 late fee for any and all monies collected after the agreed upon date.
- Parent and Player understand that there are no refunds of any monies paid once a player accepts a spot on a team for any reason up to and inclusive of injury, mental health, and family relocation, dismissal from program due to violation of Team policies, JVA Policies, USAV Policies, or AAU Volleyball Policies unless otherwise advised by the Club Director. (See USSIC)
- Parent and Player understand that monies paid to the FreeState Volleyball Club do not guarantee any particular amount of playing time, positions within a team lineup, leadership roles, or duties.
- Player and Parent understand that monies paid to participate in the FreeState Volleyball Club constitute a commitment to the team. On occasion, some players may be moved to other teams for competition purposes. The Parent and Player agree that they are responsible for their signed and agreed upon team fees regardless of the team they compete on for any given event. The FreeState Volleyball Club will not seek further compensation if a player moves rosters at their discretion, however if the Parent or Player requests a team change that is in excess of their current fee agreement, they are responsible for the additional fees.
- Parent and Player understands that all team fees are to be paid using the web based automatic payment system set forth at [www.FSVolleyballclub.com](http://www.FSVolleyballclub.com) and administered through the Sports Engine portal. Parent and Player understand that any and all Sports Engine processing fees and any fees associated with NSF/Declined Credit or debit are the direct responsibility of the Parent and Player. Parent and Player authorize the FreeState Volleyball Club to invoice their account in the FreeState Volleyball Online Payment System in the initialed payment option.

The remaining balance will be divided into 4 equal monthly payments due on the following dates: Jan15th, Feb 15th, March 15th, and April 15th in the amount of \$288.00

\* I understand that the credit card that I designate will be automatically be charged on each date for a 1/4 of the total fee balance (less any deposit already paid). It is my responsibility to ensure that a current credit or debit card is maintained on file until all club fees are paid.

Furthermore, Parent and Player agree that the FreeState Volleyball Club is providing a service, rather than a product, and therefore waives the right to dispute any payment for services made via credit or debit card to the FreeState Volleyball Club.

- Administrative Fees

Parent and Player understand that the following are NOT INCLUDED in their FreeState Volleyball Club Fees:

- Player and Parent travel expenses associated with tournaments (hotel lodging, airfare, fuel, food, etc.)
- Travel to and from Practices and Tournaments
- USAV and/or AAU Player Membership
