

## **Taylor High School Athletic Booster Club Board General Meeting Minutes from February 7, 2022**

President Brad Ingram called the meeting to order at 6:33 p.m. from the THS 9<sup>th</sup> Grade Cafeteria. Secretary Shelley Eastland was present to record the minutes of the meeting. Copies of the December meeting minutes were made available. There were 12 members in attendance via Zoom, and 3 officers and 5 guests present in person.

**Membership Report:** Darren Flynt reported 144 members with approximately \$24,250 in income from membership. Going to analyze the breakdown by sport, investigating whether spring sports might be better represented than they initially appear because dual sport athletes were only counted in fall sports numbers instead of both.

**VP – Programs + Spirit Wear:** No report submitted this month.

**VP – Fundraising:** Tonya Wallace reported 3 spirit nights scheduled for the spring. They are: **February 24** at Las Manñanitas- from 5-9p.m. mention THSABC for 20% of proceeds to benefit THSABC; **March 9** at Raising Cane's from 4-9 p.m.; mention THSABC for 15% of proceeds to benefit THSABC; **April 19** at Whataburger from 6-9 p.m., no mention of THSABC is required for 20% of proceeds to benefit THSABC. There was discussion about a multi-sport Spring Fundraiser (discount card) for the remaining spring sports who have no plans for a different fundraiser. Michael will report back to Chad Simmons with the target goal amount later this week.

**Treasurer's Report:** Michael Seago presented reconciled financials including, month-to-date income of -\$10,610.26\$ and expenses of \$5,516.30, with an overall total of -\$16,126.99. Financial reports will be available on the website later this week.

**Scholarships:** Brad reported the link is open on the THSABC website for applications. Deadline for all applications is Friday, April 29 at 11:59 p.m. Nothing will be accepted after this time. Buffy Brummett volunteered to serve on scholarship committee.

**THSABC Leadership:** Brad provided an update on recruiting to fill board positions; volunteers for all board positions except the team rep position on board have been identified. Those expressing an interest to serve are as follows: Taryn Meyer & Mark Barham - VP of concessions; Connie Pham & Asha Khanapure - VP of Fundraising; Becca Wolfgang - VP of Team parents; Keith Spiers - VP of Volunteers; Sara Brown - Spirit Wear and social media with help from Tiffany Minor, Heather Larson , and Claudia Lau- Weiss in the spirit wear department.

There also was a motion to professionally clean the football/track concession stand that was seconded and carried.

**Coaches' Reports:** Coaches shared the following updates: **Softball** – 3 weeks in, scrimmage a week ago Saturday girls played well; washed out with weather this past week but resume Wednesday at THS; fundraiser underway with plans to give a portion of the \$8,000 raised to the

scholarship fund. Tournament Feb. 17-18<sup>th</sup>. **Tennis** – playing in tournaments right now. Varsity is doing well with several tourney wins. It is going well and hoping to make regionals. Track – is underway. They had a chilly practice meet last week. First Varsity co-ed track meet Friday at CyFair. Next Thursday Taylor hosts a meet and coach wants the stands packed. Thursday is kickoff meeting with plans for their own fundraiser starting next Wednesday. **Girls Soccer** – big game against Cinco tomorrow and Katy on Friday. Brad wished our THS team good luck from their ABC.
