

# ICE ARENA

Mount Prospect Ice Arena will follow the Illinois Department of Public Health (IDPH) Sports Safety Guidance. Currently, Higher-risk sports can play at Level 3: Intra-conference or Intra-EMS-region or intra-league play/meets only; state or league-championship game/meet allowed for low-risk sports only. The following policies and procedures are based upon their latest guidance. Your compliance is required. Any violation of the below policies and procedures may result in your excusal from the building.

## FACILITY REQUIREMENTS

- Please stay home if you are showing symptoms or signs of sickness, or if you have been in close contact with a person with COVID-19.
- Guests must wear face coverings over their noses & mouths at all times while inside the facility except for when eating, drinking or when outside and able to maintain a safe social distance.
- Guests shall follow social distancing guidelines at all times while inside the facility.
- Loitering in common areas before, during, or after on-ice events is prohibited.
- Group sizes of 50 people or fewer (includes skaters, coaches, and referees; excludes spectators) are allowed in each rink with this limit subject to change based on latest data and guidance.

## PARTICIPANT REQUIREMENTS

- All skaters, including coaches and referees, must sign a hold harmless waiver before entering the facility. <https://boltshockey.sportngin.com/register/form/919865615>
- Team locker rooms are accessible 1-hour prior to scheduled ice times with the supervision of a coach or team manager.
  - Teams must remain inside assigned locker rooms before scheduled ice times; no loitering.
  - Showers are **not** available.
  - Private Locker Room tenants are **not** allowed to leave their equipment after use.
- Skaters are **not** required to wear face coverings over their noses & mouths while on the ice.
- Skaters are required to bring in and label their own water bottles; no sharing of water.

## SPECTATOR REQUIREMENTS

- Spectators are allowed inside the facility 10 minutes prior to scheduled ice times.
- Limit (2) spectators per participant.
- Spectators must be seated in the bleachers; standing along the glass is prohibited.
- Please dispose of food and beverage in garbage cans.
- Billy Bricks Wood Fired Pizza is accessible for paying customers only.
- LiveBarn is now active.
