1) Call to order

- Board Secretary Brian Anderson called meeting to order.

2) Treasurer's Report

- Pat Uhteg provided the formal list of all paid positions within the LDSC. Mike Davis is elected as the new LDSC Board Treasurer and will take over the responsibilities of club Treasurer.

3) Report of Committees

- House League:

- Spring session had approximately 650 players, Fall session with approximately 600 players. Fall session ends on 10/21. The winter session registration is open and currently at approximately 150 players, with a goal of 200 players. Registration cost went up slightly. U4/U6 groups still receive balls in spring and fall sessions only, as well as trophies. The older age groups receive an alternative award (cinch bags, medals, water bottles, etc).
- Referee shortage continues to affect house league.
- Lack of volunteer coaches, especially at the older age groups.

- Travel Soccer:

- Player registration is open and has been communicated to all coaching staff.
- Gym availability to indoor training is sparse this year.

- Tournament Committee:

- LDSC High School space would be enough to host the tournament, however the school has not provided a definitive answer if the space can be used, including cost to use the turf.
- Application to host tournament is due November 1st.
- The date of the tournament will be July 26-28.
