To participate as a _____ Grader in the Division _____ level and in any way in Jr Prep Sports Hawaii program, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. By competing against older players, the risk of injury to my child from the activities involved in these programs is significant, including the potential for permanent disability and death, and while rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and
2. FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS that may result from my child competing against older players, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my child's participation; and,
3. I willingly agree to comply with the program's stated and customary terms and conditions for competition against older players. If I observe any unusual significant concern in my child's readiness for participation in the program itself, I will remove my child from the participation and bring such attention to the nearest official immediately; and,
4. I myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE Jr Prep Sports America and their respective officers, affiliates, agents, representatives, successors, sponsors, advertisers, other participants, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH or loss of damage to person or property incident to my child's involvement or participation in these programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from all liability's incident to my involvement or participation in these programs. EVEN IF ARISING FROM THEIR NEGLIGENCE to the fullest extent permitted by law.
