



### **Safe Reopening Plan – 9/8/20**

- 1) One way entry and exit at front of building.
- 2) Physical and social distancing of 6 feet must be maintained throughout the rink.
- 3) Groups must leave promptly as soon as possible or no later than 15 minutes to avoid congregation with incoming groups.
- 4) Capacity is limited to 137 people.
- 5) Seating is limited to groups of no more than 4 people in stands that are separated by 6 feet.
- 6) Visitors must follow all posted signage and education.
- 7) Mask required at all times except during physical activity (except as allowed by State of Ohio's Director's Orders).
- 8) Frequent cleaning of high touch areas – benches cleaned after each separate club leaves the ice.
- 9) Sanitizer available in lobby and arena.
- 10) Groups perform own COVID-19 self-assessments.
- 11) Handling of sick/symptomatic will follow the guidance provided in Responsible RestartOhio for Sports Venues.
- 12) Groups must follow Locker Room Policy (attached).
- 13) Event organizer must follow reopening plan and follow all guidance provided in Responsible RestartOhio for Youth, Collegiate, Amateur, Club and Professional Sport (attached), by the Cuyahoga County Board of health, and by the Ohio High School Athletic Association.
- 14) LiveBarn streaming service is available to view on ice activities.

### **Micheal A. Ries Ice Rink Locker Room Policy**

The safety, protection and comfort of the Michael A. Ries Ice Rink's ("Ice Rink") players, coaches and visitors is of the utmost importance to the City of Parma and its Recreation Department. This policy is designed to maintain smooth operations, personal privacy as well as to reduce the risk of misconduct in locker rooms, and provide a clean and safe environment.

#### **Team and Coach Responsibility**

All game, practice, and rink scheduling must be coordinated through the Ice Rink Manager. Coaches are ultimately responsible for their team's locker room behavior and issues. Players should be monitored at all times. Team and coach are responsible to ensure respect for City of Parma property and others property.

## **Locker Room Usage**

The Ice Rink has several locker rooms assigned and available for use during each event (practice or game). Locker rooms will be open only 15 minutes prior to and after practice or a game. No team meetings or congregating allowed in the locker rooms. No more than 10 people in a room at a time. Masks must cover mouth and nose in the locker rooms and social distancing maintained as much as possible. Showers are not available for use. Coaches are responsible to keep the rooms clean and that all trash is discarded into available cans and to any damage is reported to Assistant Rink Manager on call that day.

## **Privacy**

While constant monitoring inside of locker rooms and changing areas might be the most effective way to prevent problems, we understand that this could likely make some players uncomfortable and may even place our staff at risk for unwarranted suspicion. Ice Rink personnel will conduct a sweep of the locker rooms and changing areas before players arrive, and if the coaches are not inside the locker rooms, either a coach or voluntary locker room monitors will be outside of the locker rooms and changing areas during periods of use, and leave the doors open only when adequate privacy is still possible so that only participants (coaches and players) and approved team personnel are permitted in the locker room.

## **Security**

The head coach or his/her designee is responsible to request a key by providing a Drivers License number to access to locker rooms and complete a pre- and post-check of area with Ice Rink Personnel. Team personnel will also secure the locker room appropriately during times when the team is on the ice. Ice Rink staff may enter the locker rooms for safety and maintenance reasons only. The Ice Rink is not responsible for any lost, stolen or damaged personal items.

## **Mixed Gender Teams**

Male and female players dress/undress in separate locker rooms and then may convene in a single locker room before the game or team meeting. Once the game or practice is finished, the players may come to one locker room for a team meeting and then the male and female players proceed to their separate locker rooms to undress and shower.

## **Cell Phone, Camera and Video and other Recording Devices**

Cell phones and other mobile devices with recording capabilities, including voice recording, still cameras and video cameras, are not permitted to be used in the locker rooms. If phones or other mobile devices must be used, they will be taken outside of the locker room.

## **Prohibited Conduct and Reporting**

Michael A Ries Ice rink prohibits all types of physical abuse, sexual abuse, emotional abuse, bullying, threats, harassment and hazing. Locker rooms are available for event use only.
