- Coaches were nominated and voted in.
- We will have an email vote by February 2, 2018 to determine coaches for Girls K-2 & Girls 3-4. A decision will be made on boys U-10 head coach by Friday January, 26, 2018.
- There are not enough athletes currently registered to make up a U-8 boys team. If registration remains low they will be moved up to the U-10 boy's team.

- There are currently not enough K-2 registrations. If the numbers remain low they may play games with Mid Penn. There is also limited registration of 3/4<sup>th</sup> grade girls. There was talk of bumping those girls to the 5/6<sup>th</sup> grade team if numbers remain low.
- It was recommended we have parents sign a waiver if we determine to bump up athletes to an older team.

#### **Mid Penn-**

- Raphelle sent out an email to the board members with the answers of the questions that we wanted addressed from the last meeting. Raphelle was asked by the Mid Penn President, Rob Long, to compose an email to Mechanicsburg Lacrosse Club to bring attention to the West Shore athletes registering in their program. Raphelle received a response from their director of the Mechanicsburg Lacrosse program stating RLLC is not part of the Mid Penn so they are not in violation of the bylaws. They will continue to accept registrations.
- We will table the conversation of the move to Mid Penn to the 2018-2019 lacrosse season.

#### **Fields-**

- Lisburn Fire Hall field is reserved March 1-May (Monday, Wednesday, Friday, Saturday)
- The Church Field is reserved primarily for practice- the weather will determine if we can use it for games or not.
