1. Call to Order (Dimond)

2. JHO Update/Abuse of Official Discussion (Hort/Dimond)

Player misconduct penalty on Wednesday. Player didn't leave the bench. Cited "getting my money's worth" as rationale for staying on the bench to yell after being ejected. Player was suspended for subsequent game in that tier. Player played in a different tier the next night and continued to be unruly, but not to the level that warrants being penalized.

Ideas to address abuse of officials:

- a. Change JAHA rules regarding suspensions
 - i. Add additional two game suspensions for abuse of officials
 - ii. Ban from all USA Hockey events until official suspension has been served
 1. Meaning, if you are suspended on wed and your next game in that tier is sun, you can't play in any USA Hockey events between Wed and Sun, regardless of how many games are in other tiers in the interim
 - iii. Suspension is for a certain number of days "cool down period"
- b. Discuss suspensions at board meetings
- c. Continue to reinforce the need to have a team representative who acts as a leader on their team

Reece Motion: Rule B2. Abuse of Officials. Add a clause that any game misconduct for abuse of officials carries a two game JAHA suspension in addition to the one game USA Hockey suspension.

Thomas McKenzie seconded.

Motion passes 8-1

Coutu Proposal: Rule B2. Abuse of Officials. Add a clause that any game misconduct for abuse of officials carries a one week suspension in addition to the one game USA Hockey suspension.

Due to the Reece motion passing, the Coutu proposal was not voted on.
