## **USL W League 2024 Playoff Bracket Sweepstakes**

1. Correctly guess the tournament winner
2. Number of points scored in Conference Finals Round
3. Number of points scored in Conference Semifinal Round
4. Number of points scored in Round of 16
5. Earliest date/time of Prediction submission

Odds of winning will depend on the total number of eligible entries received for the applicable drawing. Winners will be notified by Sponsor via email on or about Wednesday, July 24, 2024, at 5:30 PM ET. Each Entrant is responsible for monitoring his/her email account for prize notification and receipt or other communications related to this Sweepstakes.
