

# ACE VOLLEYBALL CLUB PLAYER AGREEMENT



Your daughter, \_\_\_\_\_, has been selected to be on the ACE \_\_\_\_\_ (Smack, National, Elite, Regional or Acer) Team. Your acceptance is evidence by your signature at the bottom of this agreement. Once registered with and having participated with ACE, the player will be unable to transfer clubs and compete in the USA Volleyball Championships.

Fees for your daughter for 2019-20 are \$ \_\_\_\_\_ for the club season. A non-refundable \$500.00 or \$750 (\$275.00 Metro) down payment due upon signing is required. ACE will discount 5% for paying in full at signing. Payment plan is available in six installments as set out in the Cost Breakdown and Payment Schedule. Fees are due on the first of the specified month and are late on the 10<sup>th</sup> day of that month. A late fee of \$20.00 will be added on the tenth day of said month. Your daughter will be benched until your fees are brought current and late fees paid. This is a binding commitment to pay full fees. **Stopping your daughter from playing will not void your obligation to pay all fees as set out by this agreement!** Failure to pay may result in legal action. ACE will seek remaining fees, court filing fees, Attorney fees, uniform fees, and all fees associated with litigation cost. Ace will release Agreement obligations to players with season ending injuries during a USAV/ ACE Volleyball sanctioned event or family employment transfer out of area (medical or employment proof is required for release.) If Player's family is paid in full the fees paid from next full month and remaining months will be paid back by ACE upon proof. Player's family must fulfill the payment in the month of injury or transfer, and may discontinue future payment if proof was provided.

Practice and games are mandatory for all Top and National teams except for mandatory school functions or illness. Elite and Regional teams require 75% attendance. However, missed times will hurt the whole team and it will be coach's discretion to choose players on the court that will help the team's success. Playing time is never guaranteed during games. Club volleyball is competitive ball with the goal to win each game or tournament.

ACE will provide uniforms and accessories, which must be worn (and replaced if lost or stolen), tournament and qualifier fees, hotel rooms for players (see exception on Cost Breakdown), coach and chaperons, gym rental, practice time and coach wages. If a team qualifies for National tournament, the team is required to attend. Added fees for travel, practice time and coach's wages will be billed to each player's family. Top teams that do not qualify for USAV Nationals may attend AAU Nationals in June

This Agreement, together with any attachments noted will be governed by Tarrant County, Texas, supersedes all prior or oral representation or communications between the parties, constitutes the entire understanding of the parties regarding the subject matter of this agreement, and may only be modified or amended by written supplement signed by both parties.

Maintaining specific membership or position on a team will be the discretion of ACE. ACE Volleyball or Arlington Courts will not assume responsibility for injuries, damages or losses which may occur to a player or guest. Signing this agreement releases this organization from all liability. It is advised that each player consult a doctor to assure player is physically fit to play. Post season play is not included in this contract price. All players/teams qualifying for post season play are required to attend.
