Quick follow up to association leaders,

The credential checks last weekend went very smoothly last weekend. Thank you all for the work in helping teams prepare. We only had a few suspensions necessary for unserved GMs or having players participating ineligibly without/before being rostered. As much as that has been a focus for several years, we are still getting teams claiming they didn't know or that it was just an oversight. I had to laugh on one that claimed that their association never told them but forwarded an email with the warning in bold red print telling them to review their documents and respond if there are any omissions, errors, or changes needed.

Another common theme was expired coaches. In the email that I sent to coaches and managers, I warned them that expired or redlined coaches are no longer on their roster and can no longer participate with the team. I added that they should remove them from GameSheet documents (as well as ineligible players) as the presumption will be that they participated if they are on the scoresheet.

Moving forward, our next group is the non-state teams, JV, and girls that will be credentialed on January 25, 2026. We are still working on times (it will be in the afternoon). This is mandatory and we will not chase teams like we did last year. I will be sending individual emails seeking contact information for these teams.

For those hosting round 2 district games, the officials will be scheduled by D4 RIC Williams. You will collect money from the teams and then be responsible for paying the officials and scorekeeper/timekeeper/trainers.

I passed along a reminder to teams to follow up with you to assure that they have the proper documentation going into credentialling. Please forward this to your association registrars.

Looking forward and past the District credentialling...I wanted to wait to avoid confusion of different dates, but yet give you advance notice as well.

We will hold our **non-state** credentialling Sunday, January 25th in the afternoon. This will likely be in Livonia, but I will confirm the location once it is confirmed.

Credential checks are mandatory for all teams and required for eligibility. Last year's process went very well overall and the team managers or coaches attending were great (we only need one person attend the non-state check since they are not scheduling any games). One thing I will mention is that we will not chase teams like we did last year. Failing to be credentialled will lead to a disciplinary hearing, and we can review the paperwork at that time.

Just sending a reminder to teams for district credential check. There are some items that you will need to obtain from your association registrar, so be sure to check with them to see what availability or hours that have over the holidays.

Rosters: Must be the official stamped USA Hockey roster including city and state (not the zip code version, since it would take days to cross check each of them). Remember that expired coaches will be removed from the roster and may not participate. If you are working on last minute things, it may be tight to get an updated roster in time.

Team History: Your association should have covered rostering at the beginning of the season, this will document dates that players were added/dropped or teams were submitted to be rostered.

Credential Verification Sheet: This will be printed by the association registrar and must be filled out to document that all players have participated in the required number of games for your division (see charts online).

Game Log: I the area where it asks if there were any Game Misconduct or Match Penalties, it would be helpful if you mark down the number of the player receiving the penalty (or HC/AC, etc).

Samples and instructions are on both the D4 website and the MAHA website.

I noticed that Farmington Hills remodeled their upstairs and added a workout area where we scheduled games. They have some smaller officers, but space may be tight. Please bring your scheduling materials to make this flow from one group to the next smoothly.

The D4 Council and I will have limited availability during the holidays. Most of our hockey related efforts will be seeding and making sure that GameSheet framework is ready for the Round 1 games.

Association Leaders,

The message below was sent to all teams that have registered for districts. I used the information from registrations, so you may want to share with your teams to make sure they had the correct information listed.

Please forward the information to your girls teams since they do directly to states and I do not receive a contact list.

Credentiailling for District/State entered teams is January 3, 2026.

The date for non-state teams will be sent at a later time and will be later in January.

The process for AAA/Tier 1 credentiailling will be sent in a separate email.

The registration deadline for JV/Prep teams, 16U-B, and 18U-BB is **December 15, 2025**. Please pass this along to any affiliate JV/Prep teams that you handle rostering for.

One additional thing to share with your teams is that the 30% rule is required to be eligible. In the past, teams have been in violation of this and claimed to have other games scheduled to correct the number. The State Playoff Committee this year is making this a focal point, so please be sure that your teams are in compliance in terms of playing within their age group and level.

Many other items are on the MAHA D4 website (which has recently been updated). This included the district rules for Locker Room Monitors. Locker Room Monitors will be another point of focus in districts and states as there has been talks of SafeSport beginning audits of these rules.

Thank you for the associations that have shared the dates and costs for Round 2 districts. We are still waiting on two associations to reply and a couple more that we have dates but no costs for. For the two associations, please check with your assigned representative to schedule the games (search "D4 Districts Round 2" for that email chain).

As always, thank you for all you do and note that I added extra appreciation in the below letter to the associations that help their teams prepare and help the credentiailling process run smoothly on this long long day for us.

Hello Coaches and Managers,

I am happy to announce that we have things running smoothly, and I can get the information about districts out much earlier than in the past. There is so much planning that has already gone into districts...we are looking forward to the fun part when games start up.

Below you will find some links and other important information that will help you prepare for credentialling and districts.

Please refer to the MAHA State Playoff webpage at <https://www.maha.org/stateplayoffs> for forms and to view a video with instructions on completing the credential packet. Thank you to the associations that help their teams get their packets together and review the documents for teams ahead of credentialling! Your help is noticed and always appreciated.

Both the District 4 and State Playoff Guidebooks are posted on the D4 website at <https://www.mahad4.org/page/show/9281047-district-and-state-tournament-guidebooks>.

Please be sure to have two representatives from your team attend credentialling! We have 71 teams to credential, as well as girls' teams. Credentialling are some of the busiest days for the District Council and we appreciate your assistance in making things go smoothly for everyone.

We do NOT have access to GameSheets, so teams are expected to bring printed copies of all scoresheets. These scoresheets must include all information including penalties. All scoresheets must be signed by officials; if a handwritten scoresheet was transferred to GameSheets, both must be presented at credentialling.

We will continue to focus on suspensions during credentialling. With over 100 Game Misconduct and Match Penalties this year in District 4 alone, we have a lot to keep track of. The new process of teams submitting incorrect scoresheet within 7 days has worked well with almost 20 errors caught. That's said, we will not make any corrections at credentialling. Any suspension not properly marked on the scoresheet will be deemed to have not been served.

Please note that Head Coaches are responsible for tracking supplemental penalties (either players 4+ in a game, team 12+ in a game, or progressive major penalties). Remember that "2 and 10s" are technically a minor plus a misconduct penalty and count as two penalties. Teams found to have unserved suspensions may lead to additional suspensions for players or coaches, up to being suspended pending a hearing for playing an ineligible player.

Credentialling dates for District/State teams only (other teams will be credentialled at a later date). All credentialling will be done at Farmington Hills Ice Arena at 3550 Eight Mile Road Farmington Hills, MI 48335.

One important note is that ALL district and playoff games must be completed on GameSheets with updates emailed to Kim Gearn at [kimgearns@comcast.net](mailto:kimgearns@comcast.net) within 24 hours after the game by BOTH teams. This will allow the most accurate information to be posted on the D4 website.

Round 1 games will be scheduled at credentialling, can start as soon as they are entered into Gamesheets (hopefully we will be able to complete this quickly), and must be completed by January 25, 2026. These games will be played on home team ice with home teams responsible for scheduling officials. Please bring the rates you pay for officials to credentialling since each team is responsible for the cost of one official. Tier III/B teams will be placed into divisions by card draw and Tier II teams will be seeded in a snake format based on MyHockeyRankings as of December 26, 2025.

Round 2 games will be played at the rink of the division host association. I have requested cost and dates from each of the host. Those cost (including ice fees, official costs, medical personnel (if required), and timekeeper/scorekeepers) are paid to the host association by teams advancing to round 2. Some smaller divisions may have the top two teams advance directly to District 4

Championships. We heard a lot of positive feedback regarding having round 2 be designed as a semifinal compared to a long and more expensive 8-team tournament format. We will continue to use this style, with the top four teams advancing. Tier II teams will be placed based on the original seeding with the top seeded team playing the lowest seeded team advancing, and the second and third seeded playing each other. Tier III/B teams will play with the winners of each division playing the 2nd place team of the opposite division.

I know it all seems like a lot, but these are necessary steps to assure that all teams are on a level playing field in terms of MAHA and USA Hockey requirements. Your efforts are greatly appreciated and we are always thankful for those teams who arrive with all documentation completed and organized.
