



District 11 - League Playing Rules

1. All District 11 league games will be played in accordance with the rules of Minnesota Hockey and USA Hockey.
2. All teams that participate in the District 11 League shall play in the playoffs. Teams that choose to not participate will be fined \$500 and will pay the cost of (2) playoff games to the host association of that level. All fines payable to District 11.
3. Approved and Certified USA Hockey Rosters must be available at each game for the proper verification of players and coaches.
4. The home team shall be responsible for reporting the game score and scoresheet within 24 hours of the scheduled game time. Scores and scoresheets should be emailed to the District 11 Scheduler at district11scores@gmail.com. The below procedure must be followed when reporting all scores:
 - Playing level & Game date in subject line of email (e.g., Bantam A Score - 12/01/20)
 - Name of teams, score of game, total penalty minutes for each team, and whether each team received their "Fair Play" point (yes or no) in the body of the email
 - Take a picture or scan a copy of the WHITE - TOP COPY of the completed SCORESHEET and email to district11scores@gmail.com. The only acceptable copy will be the TOP - WHITE COPY of the scoresheet. Scoresheets must be legible and filled out correctly (level of play, date, scoring and penalty summary and total score including scoring by period sections must all be filled in on the scoresheet).

Failure to comply with any of the above (late or missed score report, incorrect or missing information on scoresheet, wrong copy of scoresheet, or illegible scoresheet) will result in \$50 fine to the home team per occurrence. Failure to report the late game score within 72 hours will result in a forfeit of the game for the home team and they will be awarded zero points in addition to the fine.
5. Games postponed due to inclement weather must be made in ample time to allow a minimum of 2 hours notice to coaches and referees. In addition, the home team will contact the District 11 Scheduler to inform of the postponement. The rescheduling of the postponed game must be made within 7 days of the postponed date and the rescheduled game must take place at least 1 week prior to the completion of league play. Failure to reschedule a new date within 7 days will result in a \$150 fine per team. Failure to reschedule the postponed game within 14 days will result in a forfeit of the game with zero points awarded in addition to the \$150 fine. Rescheduled game must be made via submitting District 11 Game Rescheduling form to the District 11 Scheduler for final approval. All fines payable to District 11.

6. Scheduled league games may only be changed for the following reasons: school functions, church functions, lost ice time due to high school hockey rescheduled games, or extraordinary team sickness. In the case of team sickness, the game shall be played unless the amount of team skaters drops to below the following: Squirts/10U less than 8, Bantams/15U/Pee Wee/12U less than 10. If a game needs to be rescheduled for reasons other than above a \$150 rescheduling fee will be assessed to the team initiating the schedule change. All rescheduled games regardless of reason must be submitted using the District 11 Rescheduling form and emailed to the District 11 Scheduler for approval. Rescheduled games for above reasons must be made within 7 days and the rescheduled game must take place at least 1 week prior to the completion of league play. Failure to reschedule a new date within 7 days will result in a \$150 fine for the team initiating the rescheduled game. Failure to reschedule the postponed game within 14 days will result in a forfeit of the game with zero points awarded to the initiating team in addition to the \$150 fine. All fines payable to District 11.
7. League games that are scheduled on Friday thru Sunday may be postponed by mutual agreement between both teams for the reason of filling a local tournament. There will be no fines imposed for this situation. The initiating team must follow the procedures outlined in Rule #5 to reschedule this game.
8. If a team fails to show for a regularly scheduled league game, that team will be responsible for all fees associated with the game (ice and referee fees) as well as the \$150 rescheduling fee. Procedures and fines per Rule #5 apply to the rescheduling of this game. All fines payable to District 11.
9. Playing time for each level for league play will be as follows:
 - Bantams - (3) 17 minute periods (converts back to (3) 15 minute periods for District, Region & State Tournaments). *ALL games for the 2020-2021 season will be 15 minute periods.*
 - Pee Wees, Girls 15U & 12U - (3) 15 minute periods
 - Squirts & Girls 10U - (3) 12 minute periods
- a) Overtime for league games will be as follows:
 - Bantams, Pee Wees, Girls 15U & 12U - (1) 8 minute sudden victory overtime period. If the teams remained tied after the 8 minute overtime period the game will result in a tie with each team awarded 1 point.
 - Squirts & Girls 10U - No overtime. If a game is tied after 3 periods each team will be awarded 1 point.
