Santa Fe Hockey Association MISSION

Santa Fe Hockey Association (SFHA) is a youth hockey club with a mission to promote and foster the growth of amateur hockey in the Southwest by providing opportunities for girls and boys of the Santa Fe Greater Metro area to succeed on the ice and beyond.

Santa Fe Hockey Association VISION

SFHA fosters amateur sports instruction and/or competition in the sport of ice hockey by supporting and developing amateur athletes for that competition. SFHA achieves its mission by providing supervised hockey programs in recreational, competitive, and high school teams.

Santa Fe Hockey Association Board of Directors

1. Each director shall be elected to office for a two-year term.
2. Each director shall serve until their successor shall have been duly elected and qualified.
3. The number of Directors of the Corporation shall be not less than three (3) and not more than fifteen (15)
4. Directors are permitted to hold office multiple terms and they may hold successive terms.
5. The annual meeting of the Board of Directors shall be held at 10:00 a.m. on the first Wednesday of June of each calendar year.

6. The Officers of the Corporation are to be elected annually.
7. Each officer shall hold office until the officer's successor shall have been duly elected.

9. The Committees of the Corporation are to be elected annually.
10. Each such committee shall have at least one member; directors may serve on multiple committees.
11. The Board of Directors may appoint from among the Directors one or more committees, including but not limited to:
  - a. Executive Committee
  - b. Marketing Committee
  - c. Coaching Committee
  - d. Hockey Development Committee
  - e. Fund-raising Committee
