**10U Rule 24 Discussion**

The Committee reviewed the Player Development Committee's recommendations regarding Rule 24. After a roundtable discussion among the voting members in attendance, the Committee agreed to advance a rule change proposal to the PNAHA Board of Directors for consideration at the Winter Meeting. The proposal will outline a hybrid model for 10U play that maintains half-ice as the default format while permitting limited full-ice opportunities, consistent with the Player Development Committee's developmental guidance.

The Committee also discussed the timing and process for adopting 10U League Rules and format. Members suggested creating a provision authorizing the Competition Committee—guided by the Player Development Committee on developmental matters—to establish and adopt league-specific rules outside of the normal January/Winter Meeting rule-change cycle.

The Chair confirmed that draft amendments to Rule 24 will be circulated to Committee members for review on 09 December 2025, with a formal Rule Change Proposal to be submitted on 10 December 2025 following incorporation of Committee feedback.

**Next Steps and Key Dates**

- The Competition Committee Chair will provide the Governance Committee with the proposed rules changes listed above by 10-December 2025.
- The Competition Committee will reconvene after the PNAHA Winter Meeting to discuss and evaluate changes to league rules for the 2026–27 season. This process will ensure that any proposed adjustments reflect developmentally sound principles and address the statewide competitive and operational considerations identified by Competition Committee members at this meeting.
