



Oregon USA Gymnastics State Committee Meeting
June 14th, 2020 Salem, OR

I. State Chair Call to Order (Molly)

1. Meeting called to order at 1:16pm
2. In attendance: Molly Gill, Kelsey Kottek, Casey Chandler, Lynn McCaffrey, Meg Doxtator (SAC Elect) and Debbie Anderson (NAWGJ). By phone: Heidi Fogarty, Susan Engle, and Khumbulani Moyo

II. Financials (Molly/All)

1. Account balance is currently at \$15,083.40.
 - Only outstanding expense will be for the food for today's committee meeting. The credit card has a credit balance on it since we got the refund from regional air fare.

III. State Meets (Molly/All)

1. The committee discussed fall season and having a fall state meet.
 - It was decided to do a survey monkey to see what clubs would compete in the fall and go to the state meet. Bid forms will be provided to the state for fall and Xcel state since USGA has declined hosting it in 2021.
2. The committee discussed adding an Xcel declaration deadline for those athletes who are moving from JO to Xcel.
 - Casey Chandler proposed that Feb 22nd be the Xcel declaration date as well as the JO optional drop back date and event specialist date for 2021.
 - The proposal was seconded by Kelsey Kottek
 - A unanimous adoption of the proposal was made by the committee.
3. The committee discussed allowing those athletes who qualified to a spring meet in 2020 to be automatically qualified to a championship meet in the 2020/2021 season.
 - Heidi Fogarty proposed the qualifications from 2020 spring allows athletes to automatically qualify to a championship meet in the 2020/2021 year if they are competing at the same level.
 - The proposal was seconded by Kelsey Kottek
 - A unanimous adoption of the proposal was made by the committee.

IV. Regional judges review (Molly/All)

1. In the spring the committee voted that the judges that were assigned to judge at the 2020 Regional meet would be assigned to judge in 2021. The committee discussed the possible changes that could come up over the next two years and they will re-vote on a new proposed rotation as those changes happen.

V. Upcoming events: (Molly/All)

1. Regional clinics – see calendar (these camps are tentative, and Tiffany Quincy is looking for suggestions regarding these clinics.
2. National Congress: Virtual – August 7th thru the 9th
3. Region 2 Congress: CANCELLED
4. The committee reviewed championship meet dates which are notated in the March committee minutes.

VI. New Items: (All)

1. Casey Chandler discussed with the committee doing some YouTube videos from the clinicians that would have participated in our state clinic and boot camp. He asked if we could give them a gift for the work they will do, and this was given an affirmative response. He will work with Meg on all the details and put together something for all our professional members in Oregon. He hopes to have this completed by the end of July 2020.

1. The next scheduled meeting will be in conjunction with the state meet in December, however it may be necessary to hold a zoom meeting prior to that to further discuss the fall schedule (due to Covid-19).
