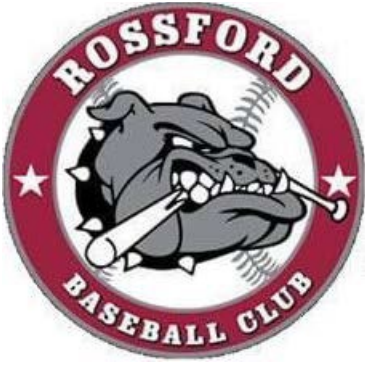
**The exact size, shape, and placement of your logo will be determined by the number of sponsors we receive.**
