

ONTARIO SOCCER GRASSROOTS PLAYER MOVEMENT FORM AGREEMENT

Between Organizations operating Grassroots Soccer

Intent: To allow organizations operating Grassroots programs to affiliate with one another, in order to fill the gaps at certain age groups and be able to offer suitable programs for Grassroots aged players if an equivalent program is not offered at one organization.

This "Player Movement Form Agreement" is subject to the following Terms:

1. With the permission of their District Association and Ontario Soccer, a "Grassroots Player Movement Form Agreement" must be signed by two Organizations under which they agree to allow players to play for the affiliated Organization that offers a suitable program at the specified age group as a result of the other affiliated Organization not being able to provide an equivalent program.
2. A grassroots player registered with an Organization that operates grassroots "squads" is permitted by his/her Organization to play with another Organization that operates grassroots "squads", subject to a "Grassroots Player Movement Form Agreement" between the two Organizations.
3. The "Grassroots Player Movement Form Agreement" must be approved and filed with the following organizations in order to be in effect:
 - a) Ontario Soccer
 - b) the District Association with which the two Organizations are affiliated
4. A "Grassroots Player Movement Form Agreement" between two Organizations shall be in effect for the duration of the program only but may be renewed if approved by Ontario Soccer and the applicable District Association.
5. Either Organization may terminate the "Grassroots Player Movement Form Agreement" at any time during the year by providing notice to the other Organization and by submitting a copy of the written notice to:
 - a) Ontario Soccer
 - b) The District Association with which the two Organizations are affiliated
