SACC – Marlyce Morace (Elected 2023)

Appointed Positions (Non-voting Members)

Assistant to the SACC – Deborah Pietrafetta (Appointed 2025)

Requirements – Women’s Program member in good standing. Minimum of 21 years of age. Must have served on the SAC for a minimum of 4 years prior to appointment.

Duties Include: Assist the SACC as needed in all areas, particularly in the conducting of Annual State Membership and State Administrative Committee Meetings. Serve as Secretary recording minutes of all SAC meetings, and the codification and publication of USAG-MA Fast Facts. Represent the State in the absence or incapacity of the SACC.

Judge’s Representative – Jennifer Wrenn (Appointed 2025)

Requirements – Must be actively judging numerous Dev and Xcel competitions in MA with a minimum of a Level 10 Rating.

Duties Include: Attend all SAC meetings. Keep judging membership informed of any changes or clarifications pertaining to the season. Present to the SAC a list of all eligible & available officials for the State Championships. Serve as a liaison between the SAC and the judging membership.

State Equipment and Apparel Coordinator – Laura Buczek (Appointed 2025)

Women’s Program member in good standing. Minimum of 21 years of age.

Duties Include: Attend all SAC meetings. Scheduling and invoicing of the state equipment truck rentals. Organize all USAG-MA Apparel for Regional Qualifiers, including but not limited to sizing, ordering and distribution.

Elected Positions (Voting Members)

Xcel Representative – Bill Kane (Elected 2024)

Requirements – Women’s Program member in good standing. Minimum of 21 years of age. Be actively coaching in the Xcel Program in MA.

Duties Include: Attend all SAC and State Membership meetings. Serve as a liaison between Xcel coaching community and SAC. Must be available to attend all Xcel State Championships and assist the SACC with any necessary functions at the competition.

Membership Authenticator Xcel* – Samantha Kelley (Elected 2024)

Requirements – Women’s Program member in good standing. Minimum of 21 years of age. Be actively coaching in the Xcel Program in MA.

Duties Include: Attend all SAC and State Membership meetings. Verification of all Xcel athletes who have been entered into the State Cups to ensure proper Mobility and Qualification requirements have been met in accordance with USA Gymnastics Rules & Policies and USAG-MA Qualification procedures. Must be available to attend all Xcel State Championships and assist the SACC with any necessary functions at the competition.

Membership Authenticator Dev Program – Jennifer Belculfine (Elected 2024)

Requirements – Women’s Program member in good standing. Minimum of 21 years of age. Be actively coaching in the Dev Program in MA.

Duties Include: Attend all SAC and State Membership meetings. Verification of all Dev athletes who have been entered into the State Championships to ensure proper Mobility and Qualification requirements have been met in accordance with USA Gymnastics Rules & Policies and USAG-MA Qualification procedures. Must be available to attend all Dev State Championships and assist the SACC with any necessary functions at the competition.

Optional Representative – Michael Hahn (Elected 2025)

Requirements – Women’s Program member in good standing. Minimum of 21 years of age. Be actively coaching in the Dev Optional Program in MA.

Duties Include: Attend all SAC and State Membership meetings. Serve as a liaison between Optional coaching community and SAC. Must be available to attend all Optional State Championships and assist the SACC with any necessary functions at the competition.

Compulsory Representative – Heather Bartlett (Elected 2025)

Requirements – Women’s Program member in good standing. Minimum of 21 years of age. Be actively coaching in the Dev Compulsory Program in MA.

Duties Include: Attend all SAC and State Membership meetings. Serve as a liaison between Compulsory coaching community and SAC. Must be available to attend all Compulsory State Championships and assist the SACC with any necessary functions at the competition.

Athlete Development – Holly Crotty (Elected 2024)

Requirements – Women’s Program member in good standing. Minimum of 21 years of age. Have previously been involved as a coach/clinician in the SDC and RDC Programs.

Duties Include: Attend all SAC and State Membership meetings. Organize all aspects of the State Developmental Team, including but not limited to: Athlete Selection, Training Camp Coordination, Clinician Liaison, Apparel Ordering and On-Site SDC Direction. Must be available to attend all State Championships and assist the SACC with any necessary functions at the competition.
